Further, we write to advise that the Company was not required to effect rematerialisation of shares during the month of September 2024.

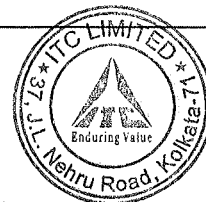

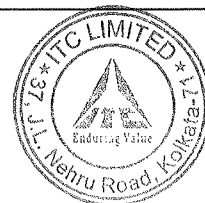
