# SRM hosts lecture on solutions to combat antibiotic resistance

Chennai, Sept 20: "The usage of certain antibiotics has nearly doubled in 2014 from that of 2010 and the resistance has resulted in over 30,000 deaths annually in the USA and Europe," said Nobel Laureate, Professor Ada E Yonath at the SRM Institute of Science and Technology (SRMIST), Kattankulathur on Monday.

Stating that antibiotic resistance is growing to be a concern in India, Ada E Yonath said that the citizens in the USA and Europe across the world spent 1.6 billion Euro on various diseases caused by antibiotic resistance in this period (2010 and 2014).

Over 3000 students and the faculty from



SRMIST took part in the lecture that delved into solutions to combat antibiotic resistance. Ada E Yonath who secured the Nobel Prize in Chemistry in 2009 presented the data that showed the significant increase in drug resistance among pathogens.

SRMIST's Registrar Dr.

Reiterating the importance of natural antibiotics, she said that they are the weapons that microorganisms of one type use for interfering with the cell life of different species. "The tiny antibiotics paralyze ribosomes by binding to their functional sites through various processes such as decoding, bonding, tunneling and hinging," Ada E Yonath said.

S. Ponnusamy delivered the welcome address. In her keynote address, she said, "Ribosomal mutations are associated with diseases such as cancer and anemia. Most of the ribosomal antibiotics are extensions of small organic molecules that cannot be degradable in the environment."

The event concluded with a vote of thanks presented by Dean(CET) Dr.T.V.Gopal. SRMIST's Pro Vice-Chancellor (Medicine and Health Science) Dr. Lt Col A. Ravikumar and the Dean of Sciences, Dr.D.John Thiruvadigal were among the others present.
