Ability to maintain operations including the factories/units/office spaces functioning and closed down	As per the government directives the Company has opened its office from 18th May 2020 with permitted minimal number of employees and the functioning of business activities tends to Also become the normal Company with time

Estimation of the future impact of CoVID-19 on its operations	As the CoVID19 pandemic is still evolving and the virus is still spreading in Gujarat region and most parts of india, the future impact of the pandemic on the overall operations and financials of the Company cannot be assessed with certainty.
Details of impact of CoVID-19 on listed entity:	There was no major volume of business during the lockdown while expenses of fixed nature have been incurred by the company. This caused the net deficiency of cash flow in the company during lockdown period and Due to this company has requested to its creditor to provide moratorium of three months in payment.
	Because of CoVID-19, it is estimated that there will no major adverse impact on overall business of the company in future due to IT equipment and infrastructure except restriction on physical excess to customer location. Consequently, profitability and net sales may not be majorly affected at the end of the year.
	Payments of creditors has been deferred during lockdown and extended for further month which had been paid after lockdown period in the month of June, 2020.
	There is no impact on the Internal Financial Reporting and Control.
	Due to lockdown and other specific restriction, the service operations of business have affected in that particular time period.
Contracts /Agreements Obligations that impact business of Company:	The Company is closely monitoring the contractual obligations against the customers and other parties and there is impact on business of the Company due to nonfulfillment of the obligations by other party.
