HFCL bags approval under PLI Scheme; will avail an incentive up to Rs.652.79 crores

- HFCL has been granted approval to avail incentives upto Rs. 652.79 crore as part of Government's production-linked incentive (PLI) scheme
- HFCL has committed an investment of Rs. ~425 crore in PLI scheme for manufacturing of telecom products including 5G Radio equipment, Routers, Switches, WiFi Products and Backhaul Radios etc.

New Delhi, November 01, 2022: HFCL Limited (HFCL), a leading telecom equipment manufacturer and technology provider has announced that they have received approval on incentive upto Rs. 652.79 crore from Small Industries Development Bank of India (SIDBI), Project Management Agency (PMA) and Competent Authority designated by the Government of India on its application for participation in production-linked incentive (PLI) scheme.
