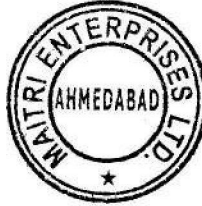

Kejriwal announces calendar for govt exams

Rajkot: Delhi chief minister Arvind Kejriwal on Tuesday announced a calendar for government recruitment by conducting various exams smoothly if his Aam Aadmi Party (AAP) is voted to power in the upcoming assembly elections in the state. Addressing a gathering in Bhavnagar's Town Hall, Kejriwal also promised to bring in a stringent law to curb paper leaks with a provision of 10 year jail term and said that all such cases registered since 2015 will be reopened to bring the perpetrators to the book. "More papers leak in Gujarat than the firecrackers during Diwali in the country," the AAP convenor alleged, dubbing the paper leaks over the past few years as a scam bigger than the Vyapam scandal of Madhya Pradesh. Referring to education and employment, Kejriwal promised to create 10 lakh government jobs in the next five years and declared a recruitment calendar. He said if AAP forms the government,
