This milestone was marked by an event in the Kaliyaka village, attended by school authorities, panchayat and community members from villages who have been positively impacted by the project.

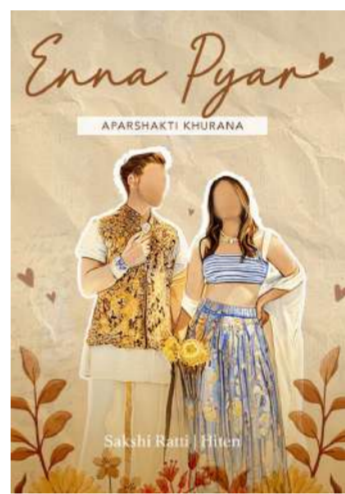
