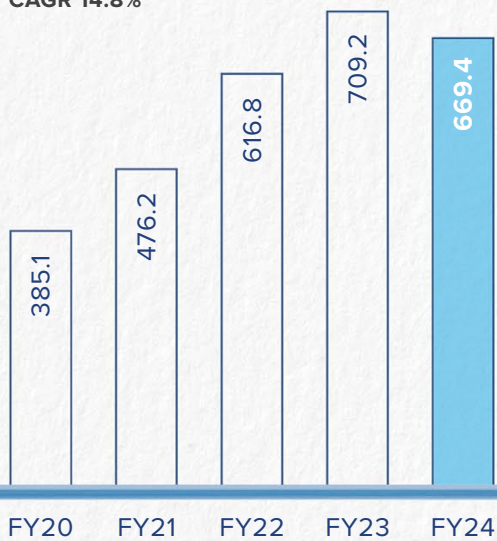

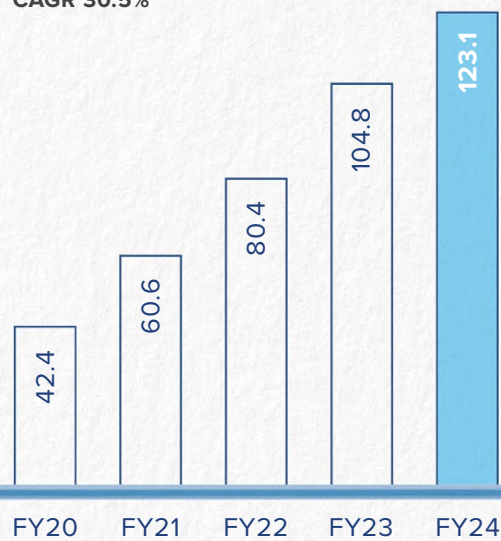

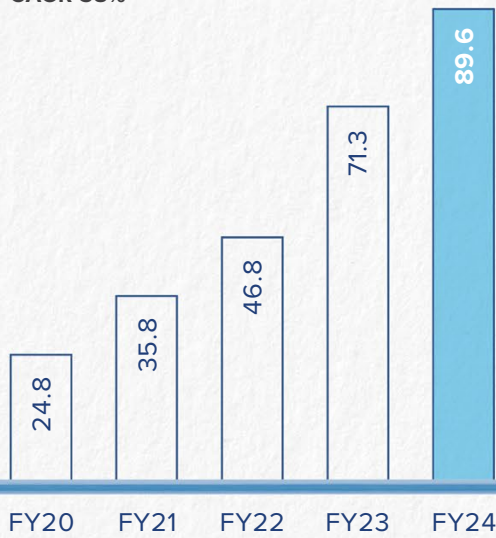

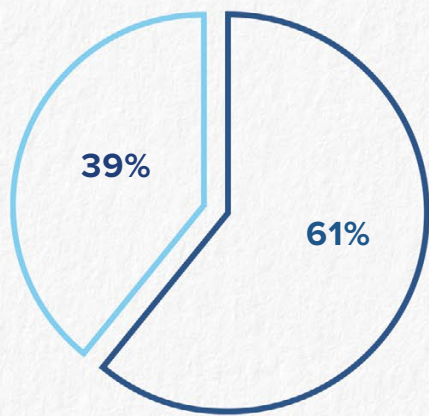


EARNINGS PER SHARE (EPS)

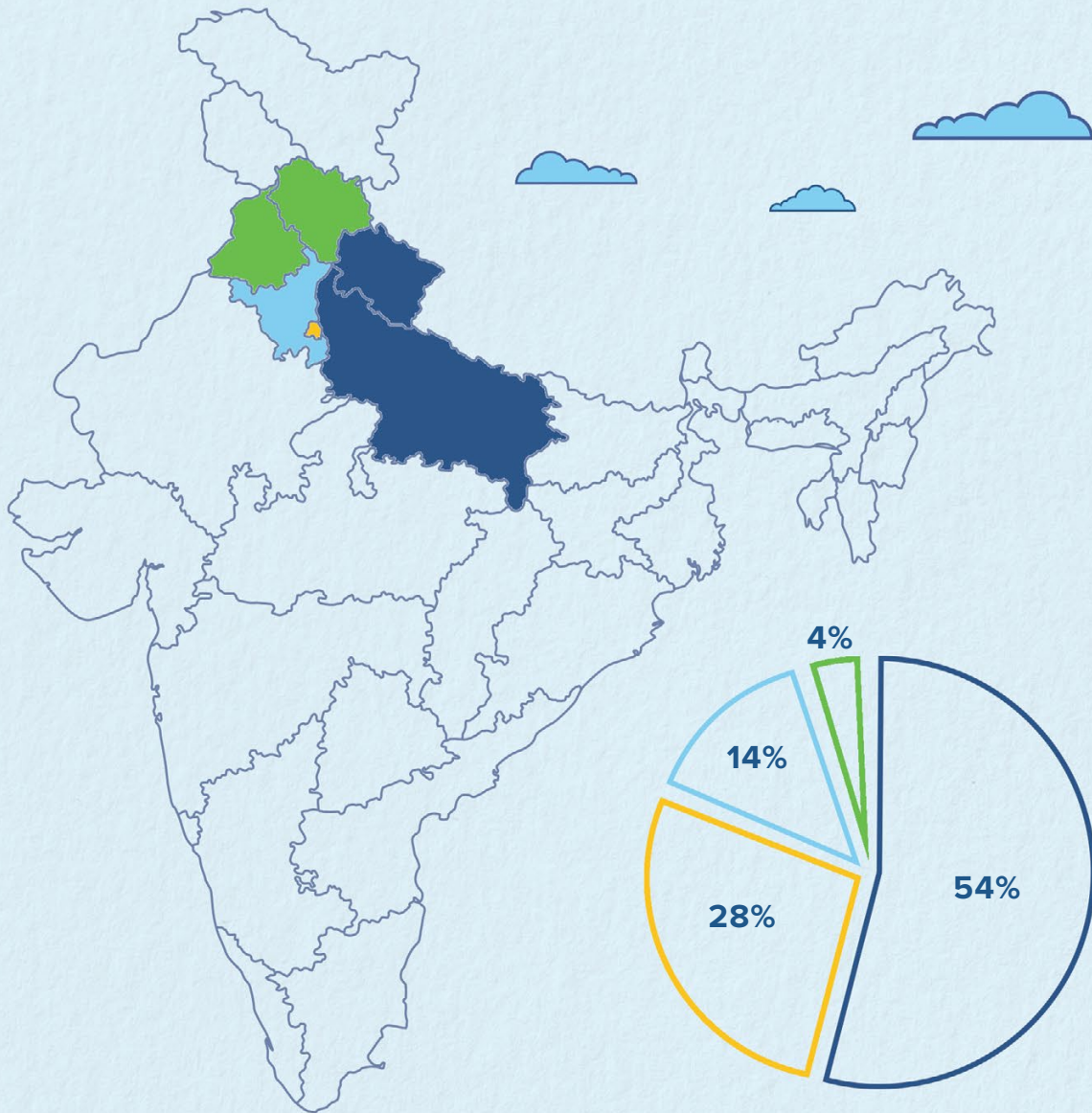

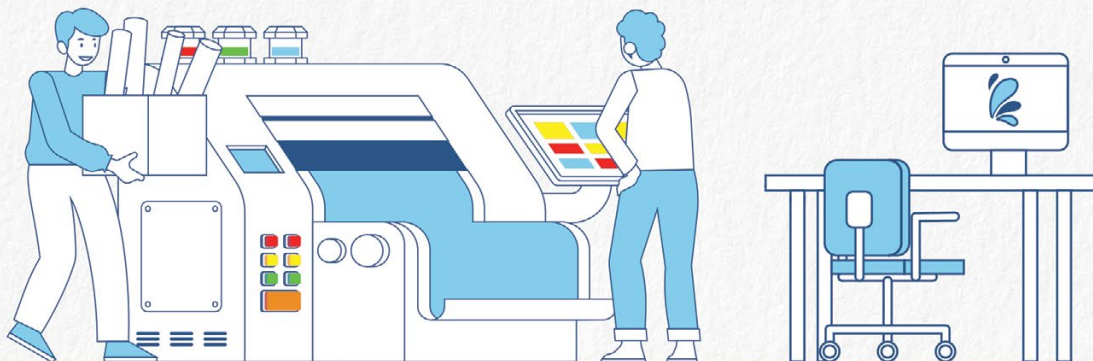

India's economy has shown remarkable resilience amid global challenges, supported by robust domestic demand, significant investments, and dynamic growth in manufacturing and services. These conditions have strengthened Prakash Pipes Limited (PPL), making us more efficient and better positioned for future growth.

FY24 was a pivotal year for us, marked by a strategic focus on consolidation and enhancing our bottom-line margins. Despite a reduction in revenue, our efforts to optimise costs and improve operational efficiencies led to a robust EBITDA of ₹123.1 crore. Furthermore, our Profit After Tax was ₹89.6 crore, underlining our ability to maintain profitability even as we navigated a difficult landscape.

Our focus on cost efficiencies has been instrumental in maintaining strong margins. Key initiatives during the year included:

Optimised Raw Material Procurement

We enhanced our procurement strategies, ensuring better pricing and availability.

Energy Efficiency

A shift from gas fuel to biomass fuel in our boilers has significantly reduced costs and our carbon footprint.

Process Flow Improvements

We streamlined processes to improve lead times and operational efficiency.

Digital Transformation

The implementation of SAP for end-to-end process accounting has provided greater transparency and control over our operations.

Looking ahead, we anticipate strong growth in our flexible packaging segment, alongside steady expansion in PVC Pipes and Fittings. Our ongoing investments in innovative packaging technologies are not only enhancing our product offerings but also ensuring that we contribute positively to our ecological footprint.

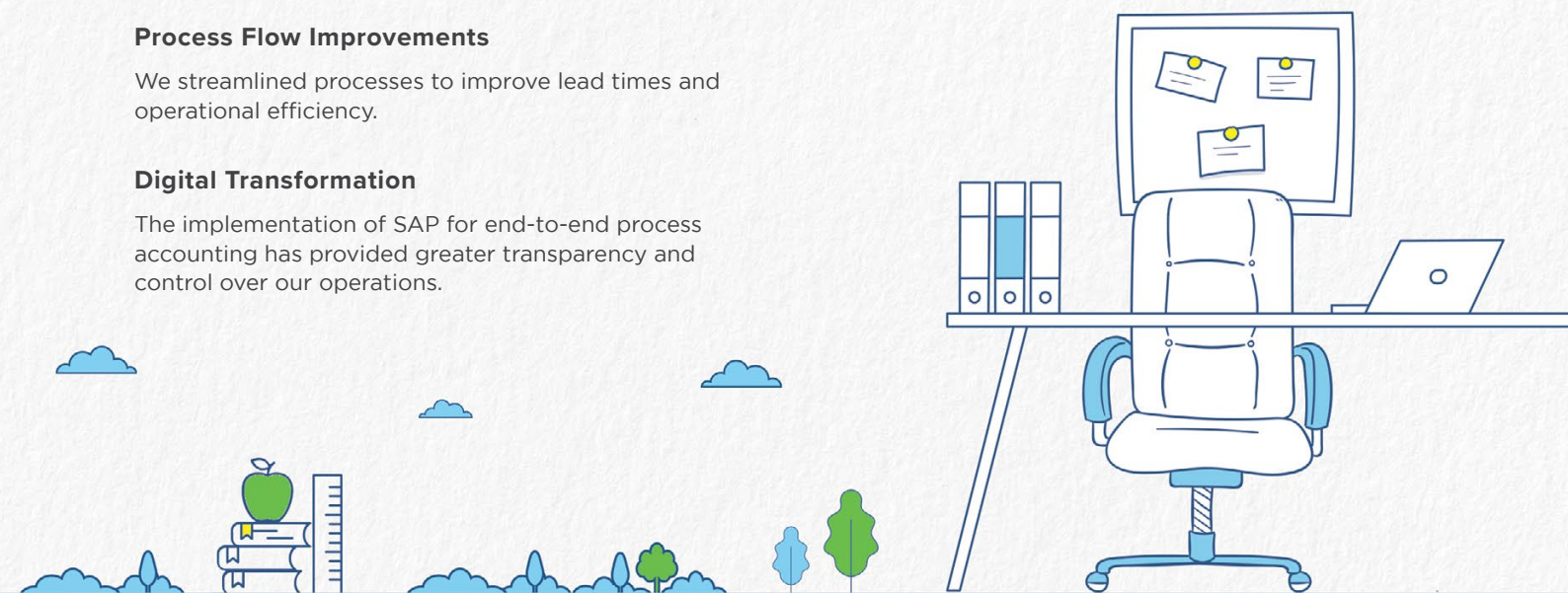
Our upcoming projects reflect our ambition to capture these market opportunities and reinforce our leadership position.

PVC Pipes & Fittings

We are entering the next phase of expansion by adding CPVC and UPVC injection moulding machines to increase our production capabilities. Additionally, we are introducing a new product line for HDPE drums, which is crucial for the pharmaceutical, chemical, and food processing industries.

Flexible Packaging

We are expanding our capacities to 36,000 MT over the next two years, focusing on extrusion-coated and laminated structures. Significant investments are being made in high-output, high-performance machinery to meet the growing demand and set new industry benchmarks.



We are committed to reducing our environmental footprint through process control, optimised resource consumption, technology upgrades, environmentally safe practices, and adhering strictly to all relevant environmental legislation and regulations.

- PPL fulfils its Extended Producer Responsibility (EPR) as mandated by the Plastic Waste Management (Amendment) Rules of 2022.
- Our PVC Pipes & Fittings division has reached a key milestone by achieving 100% recycling of process waste through re-grinding and reusing PVC pipe rejects and process waste.
- We achieved 100% recycling of Blown Poly film waste by utilising online re-pelletisation of side trims, rejects, and process waste.
- PPL effectively reprocesses laminate waste into lumps, which are then sold to manufacturers of hose pipes, chairs, and roadside barriers, contributing to efficient waste management and the circular economy.
- An annual Energy Audit, conducted by BEE-certified auditors, plays a crucial role in measuring energy efficiency and identifying further opportunities for reducing power consumption.

Additionally, our commitment to CSR remains steadfast and we are committed to driving meaningful change through our CSR initiatives:

Nourishing Futures Through Nutritious Meals

In partnership with ISKCON's FFL, we provide nutritious mid-day meals to underserved school children in Delhi.

Empowering Communities Through Education

We support non-formal education for the elderly and students in villages, renovate schools, and supply essential resources.

Tackling Water Scarcity

We install and maintain deep-water tube wells in villages, ensuring sustainable clean drinking water.

PPL organises health camps, offering check-ups, consultations, and specialised healthcare initiatives in rural areas.

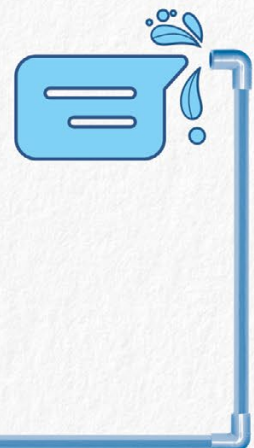

MANAGEMENT DISCUSSION AND ANALYSIS

INDIAN ECONOMY

Overview¹

India's economy has showcased remarkable resilience amid global challenges and geopolitical tensions, driven by robust domestic demand, significant investments, and dynamic growth across the manufacturing and services sectors. The Real GDP growth rate for 2023-24 is projected at 8.2%, up from 7.0% in the previous year, positioning India to become the third-largest economy within the next three years.

The banking sector's asset quality has improved notably, with the gross non-performing assets (GNPA) ratio hitting a decade low. Corporate balance sheets are healthier, with private investments on the rise. Inflation is approaching the Reserve Bank of India's (RBI) target of 4%, supported by record-high forex reserves. Consequently, the RBI has paused rate hikes, maintaining the benchmark repo rate at 6.50%. However, inflation management remains a critical focus for policymakers, with the fiscal deficit expected to stay within the 5.1% target for FY25.

India achieved a significant milestone in FY24, with service exports reaching a new high of \$341.1 billion and gross GST collections rising by 11.7% to ₹20.18 lakh crore.

The infrastructure sector is poised for substantial growth, underpinned by the National Infrastructure Pipeline (NIP), which plans \$1.4 trillion in investments by 2025. The government also aims to construct two crore additional houses under the PM Awas Yojana (PMAY). The manufacturing sector rebounded with a 9.9% growth in FY24, benefiting from reduced input costs and stable domestic demand. Construction activities also surged by 9.9%, driven by infrastructure development and strong demand in commercial and residential real estate.

India's stable macroeconomic factors, positive global perception, and stable currency continue to attract investors. Despite global geopolitical impacts on demand, fuel prices, and foreign exchange, India has maintained its growth trajectory, with a predicted rural recovery in 2024 expected to further bolster this growth.

Outlook²

India's economic outlook for FY25 is promising, with the International Monetary Fund (IMF) upgrading the GDP growth projection to 7%. This upgrade reinforces India's standing

as the fastest-growing economy among emerging markets and developing economies. The projected GDP growth, estimated between 6.5% and 7%, is driven by robust public and private investment and a strong services sector. The growth momentum is expected to continue in FY25, supported by improved goods exports, increased manufacturing productivity, and enhanced agricultural output.

A significant 17% increase in central government capital expenditure in FY24 is set to boost infrastructure investment, which will, in turn, stimulate growth across various sectors. Manufacturing, in particular, is expected to benefit from reduced input cost pressures, improving industry sentiment. Foreign direct investment is anticipated to rise, particularly in industry and infrastructure, further supporting economic growth.

Demand in the financial, real estate, and professional services sectors is expected to grow, while the manufacturing sector benefits from favourable cost conditions. The agriculture sector is also likely to see growth, driven by expectations of a normal monsoon. Inflation is projected to ease to 4.5% in FY25, enhancing consumer purchasing power. This disinflationary trend will bolster private consumption, especially as agricultural production recovers, reinforcing domestic demand, a key driver of India's economic growth.

Overall, India's upgraded GDP forecast highlights a strong economic trajectory, underpinned by robust domestic demand, solid investment growth, and a favourable inflation outlook. The Indian economy is poised to maintain its growth momentum through FY25, supported by continued improvements across key sectors.

INDIAN PVC PIPES & FITTINGS INDUSTRY

Overview³

The Indian PVC pipe industry has experienced significant growth, characterised by increasing market share and strong demand. In FY24, the industry saw a volume growth of approximately 15%, a slight decrease from the 24% growth in FY23. This robust demand, driven primarily by key end-user industries such as irrigation, water supply, sanitation, and housing, which together account for over 80% of the total demand, has been the main catalyst for increased capital expenditure (capex) by PVC pipe manufacturers both this fiscal year and the next.

The industry is marked by its adaptability, innovation, and commitment to sustainability, allowing it to meet the diverse needs of its applications. Residential real estate also plays a vital role in driving demand, particularly for plumbing applications.

The industry's operating margin has shown improvement since fiscal 2024, recovering from a significant decline in fiscal 2023 due to inventory losses following a drop in PVC resin prices. The combination of improving profitability and healthy demand prospects is expected to enhance capacity utilisation to over 70%, enabling PVC pipe manufacturers to undertake further expansion.

Overall, the PVC pipe industry is a critical component of India's infrastructure development, playing a pivotal role across various sectors, including agriculture, construction, and water management. The continued growth of this industry underscores its importance in supporting the nation's economic and infrastructural progress.

Key Drivers⁴

The Indian PVC pipes and fittings industry is primarily driven by key end-user sectors such as irrigation, water supply, sanitation, and housing, which collectively account for over 80% of the total demand, as discussed earlier.

Government initiatives like the Jal Jeevan Mission and Pradhan Mantri Krishi Sinchayee Yojana play a significant role in sustaining demand, particularly in the irrigation, water supply, and sanitation segments. Additionally, the Pradhan Mantri Awas Yojana continues to stimulate growth through its focus on affordable housing.

The industry's expansion is further supported by the proposed ₹2.65 trillion railway capital expenditure for FY25. This aligns with the rapid urbanisation trends, increasing the demand for pipes in railway and urban construction projects. Initiatives such as the Smart Cities Mission and rural infrastructure development have also contributed to the surge in demand, as PVC pipes are preferred for their durability and cost-effectiveness.

Technological advancements in materials, manufacturing techniques, and design have significantly enhanced the durability and affordability of PVC pipes, making them a more reliable choice across various sectors.

Moreover, PVC pipes are environmentally advantageous compared to traditional materials. They resist corrosion and require less energy to produce, aligning well with sustainability goals. This makes them increasingly preferred for projects focused on eco-friendliness and resource conservation.

Strategic Government Initiatives

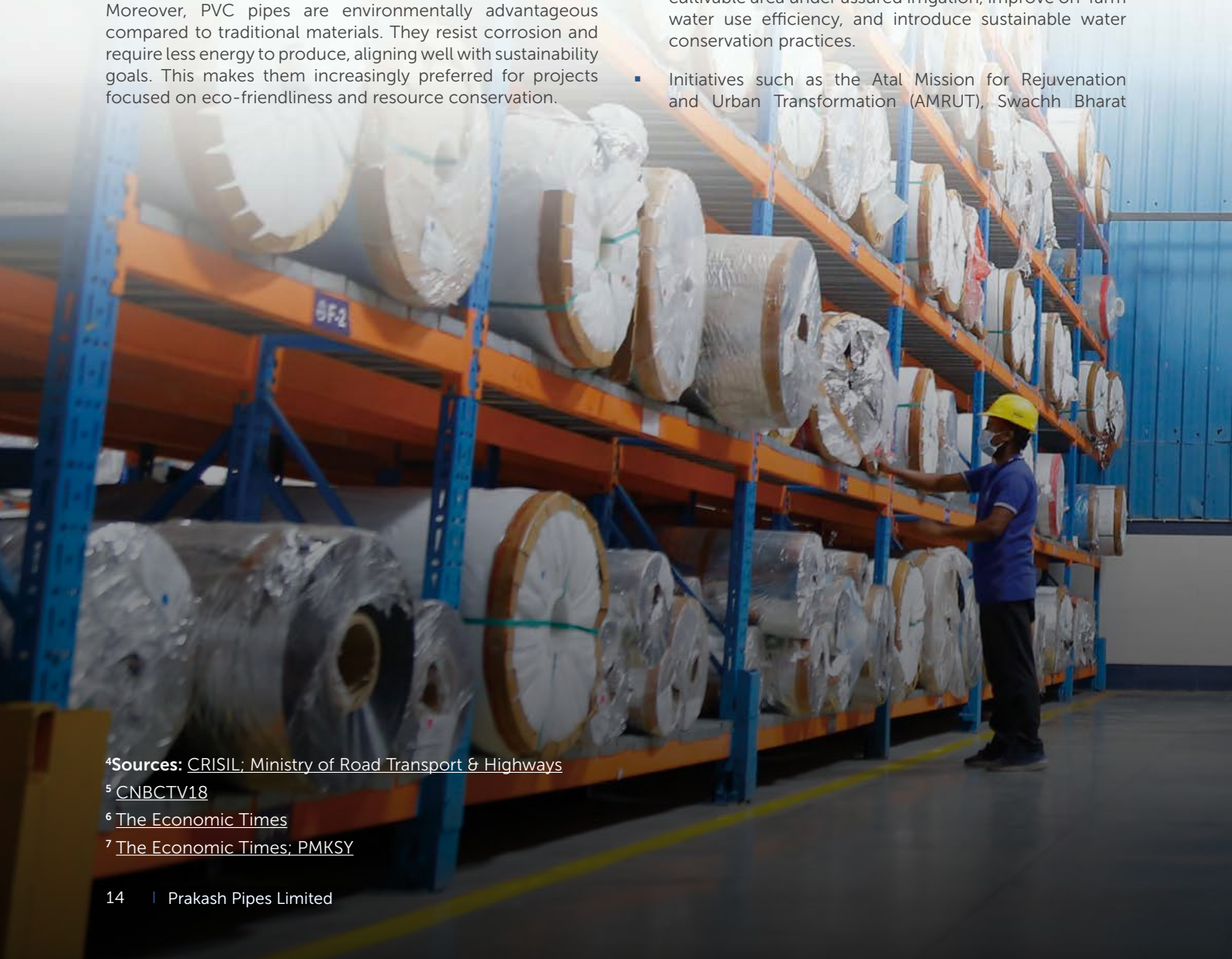
- The Jal Jeevan Mission received an allocation of ₹70,163 crore⁵ under the 2024-25 Union Budget. Launched in 2019, the mission aims to ensure every rural household has access to adequate drinking water through Functional Household Tap Connections (FHTCs). By 30th January 2024, the mission had reached 14,21,22,013 households, covering approximately 73.76% of the targeted population.
- In the 2024-25 Union Budget, the Pradhan Mantri Awas Yojana - Urban (PMAY-U) has been allocated ₹30,170 crore⁶, marking a 20.19% increase from the 2023-2024 budgetary allocation. The plan includes the construction of an additional three crore houses under the PM Awas Yojana in both rural and urban areas. This substantial increase in housing development is expected to significantly boost demand in the PVC pipes industry, given the critical role these materials play in plumbing and construction infrastructure.
- The Pradhan Mantri Krishi Sinchai Yojana has been allocated ₹9,339.37 crore⁷ for the fiscal year 2024-2025, a significant increase from ₹7,031.10 crore in the previous year. Launched in 2015-16, the scheme aims to enhance physical water access on farms, expand the cultivable area under assured irrigation, improve on-farm water use efficiency, and introduce sustainable water conservation practices.
- Initiatives such as the Atal Mission for Rejuvenation and Urban Transformation (AMRUT), Swachh Bharat

Mission, Gati Shakti plan, National Logistics Policy (NLP), and National Infrastructure Pipeline (NIP) are poised to become pivotal drivers of growth for the PVC pipes and fittings industry, unlocking new opportunities and propelling the sector towards a promising future.

Outlook⁸

The Indian PVC pipes industry is set for a third consecutive year of double-digit volume growth, projected at 10-12% for fiscal 2025. This growth, supported by internal accrual-funded capital expenditures, is expected to keep credit profiles stable. Over the longer term, the market is anticipated to grow at a compound annual growth rate (CAGR) of 5.81% from 2024 to 2030, reaching a value of nearly \$8.05 billion by 2030.

The government's focus on providing direct water connections to all households—currently at 76% coverage—along with the expansion of irrigation coverage (54% of the net sown area), will continue to drive demand. Additionally, the residential real estate sector is forecasted to grow by 10-12% in fiscal 2025, with strong demand particularly in mid-to-premium housing segments.

Healthy volume growth, combined with stable PVC resin prices—which constitute 70-75% of total costs—will enhance operating leverage and improve profitability by 100-150 basis points, bringing operating margins to 13-14% this fiscal year. PVC pipe manufacturers are expected to invest approximately ₹5,000 crore over the next two years to expand capacity by 20-25%. With limited additional debt and rising profitability,

the debt-to-EBITDA ratio is projected to improve to ~0.35x this fiscal from ~0.45x last year.

However, it is crucial to monitor potential volatility in PVC resin prices, as fluctuations could impact profitability.

INDIAN FLEXIBLE PACKAGING INDUSTRY

Overview

The packaging industry in India is experiencing significant growth, driven by the adoption of innovative packaging technologies and the expanding flexible packaging market. This market has found broad applications in food and beverage (F&B), domestic consumables, pharmaceuticals, and other sectors where extended product shelf life is essential. Despite a 45%⁹ increase in BOPET film capacity and a 20% rise in BOPP film capacity over the past two fiscal years, domestic demand has only grown by 10%, leading to an oversupply challenge within the industry. As a result, the sector has seen stock price corrections due to reduced margins. However, the industry is poised to witness significant volume growth in upcoming years.

Key Drivers¹⁰

The recently released Household Consumption Expenditure Survey highlights rising consumer spending, with ₹3,773 per month per person in rural areas and ₹6,459 in urban areas. This increase in consumer spending is driving demand for packaging, a critical factor in the growth of India's FMCG sector.

The surge in e-commerce and online transactions is significantly expanding the packaging industry's scope. With India's e-commerce market expected to reach \$188 billion by 2025, the demand for innovative and secure packaging solutions, particularly tamper-proof, lightweight, and sustainable options, is on the rise.

India's food and grocery market is among the sixth largest globally, with 70% of sales generated from retail counters. As the world's leading milk producer, India consistently demands flexible packaging solutions like pouches and tetra packs. Additionally, ecological concerns over plastics are driving the adoption of biodegradable packaging materials.

Shifts in packaging styles, advancements in flexible packaging designs, and the adoption of new technologies are also fuelling growth within the industry. The trend is moving towards greater customisation and the integration of value-added specialty films.

Strategic Government Initiatives¹¹

- The government's National Packaging Initiative aims to boost the packaging sector by setting guidelines for design and materials to ensure quality, promoting bulk transportation for efficiency, and supporting domestic businesses in producing advanced packaging materials.
- The PM Formalization of Micro Food Processing Enterprises (PMFME) scheme, with an outlay of ₹10,000 crore, was launched for five years, spanning from 2020-21 to 2024-25. This initiative provides financial, technical, and business assistance for establishing or upgrading micro food processing enterprises. To date, 43,014 such enterprises have been sanctioned for assistance across the country.
- The Indian government's emphasis on diversifying domestic production capabilities has significantly contributed to the growth of the country's packaging industry. Supportive government policies that encourage local packaging innovation and exports have further fuelled the expansion of the consumer packaging sector.
- The Union Ministry of Commerce and Industry of India aims to increase plastic exports to \$25 billion by 2025.

Various export promotion initiatives, including the New Foreign Trade Policy, Trade Infrastructure for Export Scheme (TIES), Market Access Initiatives (MAI) Scheme, and the Remission of Duties and Taxes on Exported Products (RoDTEP) scheme, present significant growth opportunities for the flexible packaging industry.

- Additionally, government initiatives to boost domestic production and manufacturing, such as the Productivity Linked Incentive (PLI) across various sectors and the Make in India programme, supported by 100% FDI through the automatic route, have driven growth and innovation within the packaging sector.

Outlook

The Indian packaging market is projected to reach \$204.81 billion¹² by 2025, registering a CAGR of 26.7% from 2020 to 2025. The "Flexible Packaging Market in India 2024-2028" report forecasts a market expansion of \$15.6 billion¹³ over the next five years, with a CAGR of 12.7%, largely driven by the FMCG sector. Industry players are expected to pursue strategic collaborations, product diversification, and customer-centric strategies to navigate the opportunities and challenges within the sector. Experts anticipate a gradual improvement in the demand-supply balance, potentially leading to volume growth and significant wealth creation opportunities in the coming years.

FINANCIAL PERFORMANCE – PRAKASH PIPES LIMITED

Revenue

Revenue from operations was ₹669.35 crore in FY24 as against ₹709.21 crore in FY23.

Expenses

Total expenses of the Company decreased by 10.27% from ₹641.34 crore in FY23 to ₹575.49 crore in FY24. Raw material costs, accounting for a 80.37% share of the Company's total expenses, decreased 12.01% from ₹525.65 crore in FY23 to ₹462.51 crore in FY24. Employee expenses, accounting for a 6.02% share of the Company's total expenses, increased 11.43% from ₹31.07 crore in FY23 to ₹34.62 crore in FY24.

PERFORMANCE

During the year under review, the Company has achieved Net Sales of ₹669.35 crore as against ₹709.21 crore in the previous year. The EBITDA for the year was ₹123.10 crore as against ₹104.77 crore in the previous year, up by 17% over the previous year. After providing for interest, depreciation and tax, the profit after tax of the Company also grew by 26% from ₹71.29 crore to ₹89.64 crore resulting in EPS of ₹37.48 in the current year.

During the year, the PVC pipes & fittings division registered sales volume growth of 10% over the last financial year at the back of operational assertiveness, efficient supply chain management, robust distribution network and brand equity. The Flexible Packaging division is closely working with customers and developing customised solutions for them. The Company expects to achieve growth in this business due to increased customer base in India and abroad.

FUTURE PROSPECTS

The domestic plastic pipes and fittings industry is in its growth stage and is likely to witness double digit growth in range of 10-12% during FY25. The sector has been continuously benefitting from budgetary allocations towards schemes like Jal Jeevan Mission and Pradhan Mantri Krishi Sinchai Yojana, and Swatch Bharat Abhiyan. Further, increase in disposable income, focus on affordable housing projects in urban, semi urban and rural areas, upsurge in demand for durable & cost-effective pipes in industrial sectors and thrust on infrastructure and irrigation projects shall also fuel the demand in the coming times.

India is one of the world's largest and fastest-growing flexible packaging markets, with growth driven by factors such as population growth, urbanization, improved quality of life, increasing hygiene awareness, changing lifestyles, convenience and consumerism. The market for flexible

packaging is estimated to grow at a CAGR of 12-13% in the next 5 years, with plastics dominating due to their moisture-resistant properties. Flexible packaging has various applications in the food and non-food industries, including ready-to-eat foods, boil-in-bag pouches, insulation, cosmetics, healthcare and FMCG sector.

DIVIDEND

The Board of Directors of your Company are pleased to recommend a dividend of ₹1.80 per Equity Share of the face value of ₹10 each (i.e. @ 18%) payable to shareholders whose names appear in the Register of members as on book closure/record date.

The dividend, if approved by the members, would involve a cash outflow of ₹431 Lakhs.

ENVIRONMENT

Your Company has always laid emphasis on its environmental commitment towards the society, including its customers, clients, employees, workers and public. The Company takes effective steps to spread the environmental awareness among its employees and motivates them to work in an environmentally responsible manner. The Company ensures compliance with all applicable environmental laws at its plants, which results in providing safe and healthy workplaces to its employees.

Company is leader in implementation of initiatives towards Plastic Waste Management by recycling, re-processing and reusing the plastic waste generated at shop floor as required under guidelines on Extended Producer's Responsibility of Plastic Waste Management Rule (PWMR) 2016 issued under Environmental (Protection) Act, 1986 (29 of 1986) vide notification dated 18th March, 2016 and amended from time to time.

In addition to complying with all applicable environmental laws and regulations, Company is committed to:

- 100% recycling of PVC Pipes Rejects/Process Waste in PVC Pipes and Fittings Division
- 100% recycling of Polyethylene film Rejects/Wastage
- Re-processing of Multilayer Plastic Rejects/Wastage for use in other applications.
- Maintaining Zero Liquid Discharge through **Effluent Treatment Plant** (ETP) for treatment of waste water and re-use.
- Maintaining for zero air pollution through installation of Gas based thermic fluid heater.
- Adopt the latest environment improvement and management technologies i.e. high efficient emission & effluent control devices for environment conservation.
- Optimum use of the resources by increasing efficiency and implementing the energy conservation and water conservation practices

The Company is responsibly disposing plastic wastes either by re-processing in-house or through certified plastic recyclers.

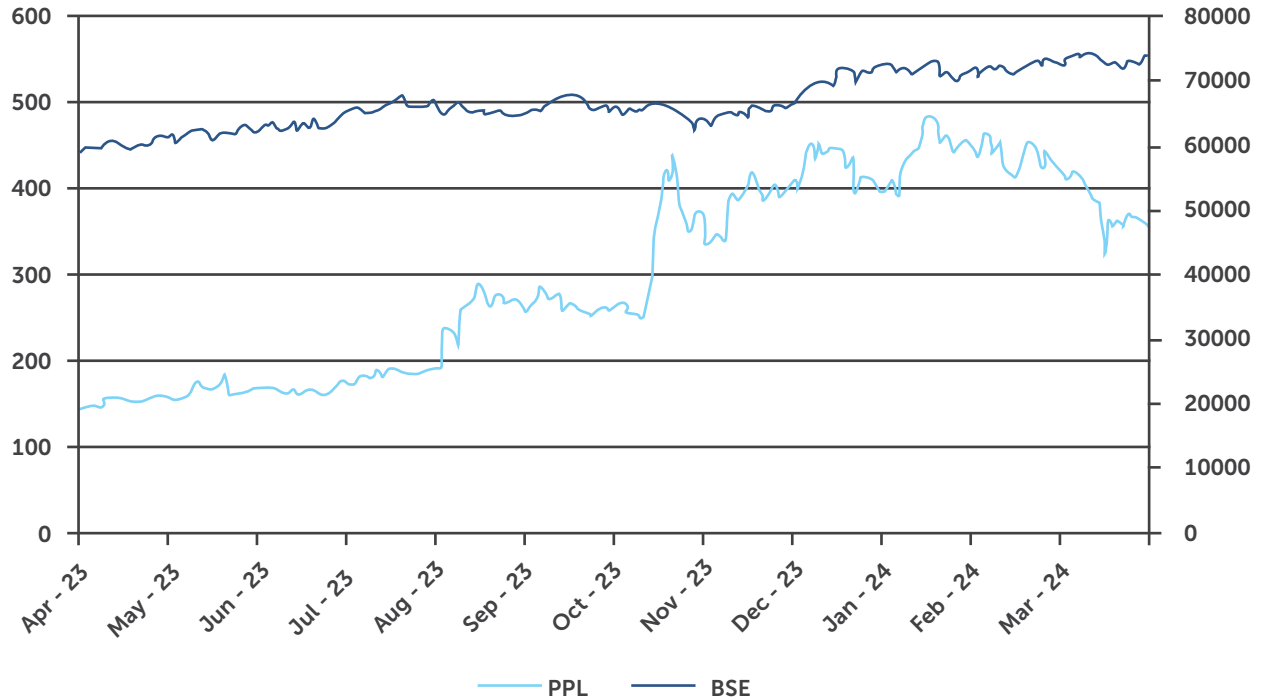

NOTES ON FINANCIAL STATEMENTS

1. COMPANY OVERVIEW

Prakash Pipes Limited (the "Company") is a public limited company domiciled in India and is incorporated under the provisions of the Companies Act applicable in India and its equity shares are listed on the National Stock Exchange (NSE) and Bombay Stock Exchange (BSE) in India. It has been engaged primarily in the business of manufacturing of PVC pipes & fittings and Flexible packaging. The Company has its manufacturing facilities in India and sells its products in domestic as well as international market.

The financial statements for the year ended 31st March, 2024 were approved for issue in accordance with a resolution of the Board of Directors of the Company dated 24th May 2024.

2. SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation

These financial statements are prepared in accordance with Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 ('the Act') read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 as amended, and presentation requirements of Schedule III to the Act under the historical cost convention on accrual basis except for certain financial instruments which are measured at fair value.

Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use.

The financial statements are presented in INR, which is also the Company's functional currency and all values are rounded to the nearest lakhs (INR 00,000), except when otherwise indicated.

All assets and liabilities, other than deferred tax assets and liabilities, have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III (Division II) to the Act. Deferred tax assets and liabilities are classified as non-current assets and liabilities. Based on the nature of products and the time between the acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for current and non-current classification of assets and liabilities.

2.2 Critical accounting judgements and key sources of estimation uncertainty

The preparation of the financial statements in conformity with the Ind AS requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities and disclosures as at the date of the financial statements and the reported amounts of the revenues and expenses for the years presented. The estimates and associated assumptions are based on historical experience and other factors

that are considered to be relevant. Actual results may differ from these estimates under different assumptions and conditions.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

Critical Judgements In the process of applying the Company's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognized in the financial statements:

Discount rate used to determine the carrying amount of the Company's defined benefit obligation: In determining the appropriate discount rate for plans operated in India, the management considers the interest rates of government bonds in currencies consistent with the currencies of the post-employment benefit obligation.

Contingences and commitments: In the normal course of business, contingent liabilities may arise from litigations and other claims against the Company. Where the potential liabilities have a low probability of crystallizing or are very difficult to quantify reliably, company treats them as contingent liabilities. Such liabilities are disclosed in the notes but are not provided for in the financial statements. Although there can be no assurance regarding the final outcome of the legal proceedings, company does not expect them to have a materially adverse impact on the financial position or profitability.

Key sources of estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

Income taxes: The Company's tax jurisdiction is India. Significant judgments are involved in determining the provision for income taxes, including amount expected to be paid / recovered for uncertain tax positions.

Useful lives of property, plant and equipment: As described in note 2.7, the Company reviews the estimated useful lives and residual values of property, plant and equipment at the end of each reporting period. During the current financial year, the management determined that there were no changes to the useful lives and residual values of the property, plant and equipment.

Allowances for doubtful debts: The Company makes allowances for doubtful debts based on an assessment of the recoverability of trade and other receivables. The identification of doubtful debts requires use of judgement and estimates.

NOTES ON FINANCIAL STATEMENTS

2.3 Operating Cycle and Current versus non-current classification

The Company presents assets and liabilities in the balance sheet based on current/ non-current classification in accordance with Part-I of Division- II of Schedule III of the Companies Act, 2013.

The operating cycle is the time between the acquisition of assets for processing and their realization in cash and cash equivalents. The Company has identified twelve months as its normal operating cycle.

An asset is treated as current when it (a) Expected to be realised or intended to be sold or consumed in normal operating cycle; (b) Held primarily for the purpose of trading; or (c) Expected to be realised within twelve months after the reporting period, or (d) The asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period. All other assets are classified as non-current.

A liability is current when (a) It is expected to be settled in normal operating cycle; or (b) It is held primarily for the purpose of trading; or (c) It is due to be settled within twelve months after the reporting period, or (d) There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period. Terms of a liability that could, at the option of the counterparty, results in its settlement by the issue of equity instruments do not affect its classification. The Company classifies all other liabilities as non-current.

2.4 Revenue recognition

Revenue

The Company manufactures and sells a range of PVC pipes & fittings and packaging products. The disclosures of significant accounting judgments, estimates and assumptions relating to revenue from contracts with customers are provided below.

Sale of products

Revenue from sale of products is recognised when control of the products has transferred, being when the products are delivered to the customer. Delivery occurs when the products have been delivered to the specific location as the case may be, the risks of loss has been transferred, and either the customer has accepted the products in accordance with the sales contract, or the Company has objective evidence that all criteria for acceptance have been satisfied. Sale of products include related ancillary services, if any.

Revenue from these sales is recognised based on the price specified in the contract, net of the estimated trade discounts. Accumulated experience is used to estimate and provide for the discounts, using the most likely method, and revenue is only recognised to the extent that it is highly probable that a significant reversal will not occur.

No element of financing is deemed present as the sales are generally made with a credit term of 30-90 days, which is consistent with market practice. Any obligation to provide a refund is recognised as a provision. A receivable is recognised when the goods are delivered

as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due. The Company does not have any contracts where the period between the transfer of the promised goods or services to the customer and payment by the customer exceeds one year.

Interest income

Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable.

Dividends

Dividend income from investments is recognised when the Company's right to receive the payment is established, which is generally when shareholders approve the dividend.

2.5 Segment Reporting

Operating segments are defined as components of an enterprise for which discrete financial information is available that is evaluated regularly by the Chief Financial Officer, in deciding how to allocate resources and assessing performance. Thus, the Company's business falls under two operational segments i.e. PVC pipes & fittings and Flexible Packaging.

Segment revenue, segment expenses, segment assets and segment liabilities have been identified to segments on the basis of their relationship to the operating activities of the segment. Inter segment revenue is accounted on the basis of transactions which are primarily determined based on market / fair value factors. Revenue, expenses, assets and liabilities which relate to the Company as a whole and are not allocable to segments on a reasonable basis have been included under "unallocated revenue / expenses / assets / liabilities".

2.6 Government grants

Grants from the government are recognized where there is a reasonable assurance that the grant will be received and the company will comply with all applicable conditions.

Government grants relating to income are deferred and recognized in the profit or loss over the period necessary to match them with the costs that they are intended to compensate and presented within other income.

Government grants relating to the purchase of property, plant and equipment are included in non-current liabilities as deferred income and are credited to profit or loss on a straight line basis over the expected live of the related assets and presented within other income.

2.7 Property, plant and equipment

Property, plant and equipment (PPE) are initially recognised at cost. The initial cost of PPE comprises its purchase price, including non-refundable duties and taxes net of any trade discounts and rebates. The cost of PPE includes interest on borrowings (borrowing cost) directly attributable to acquisition, construction or production of qualifying assets subsequent to initial

NOTES ON FINANCIAL STATEMENTS

recognition, PPE are stated at cost less accumulated depreciation (other than freehold land, which are stated at cost) and impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets. However, when there is no reasonable certainty that ownership will be obtained by the end of the lease term, assets are depreciated over the shorter of the lease term and useful lives.

Depreciation is recognised so as to write off the cost of assets (other than freehold land and capital work in progress) less their residual values over the useful lives, using the straight-line method ("SLM") in the manner prescribed in Schedule II of the Act. Management believes based on a technical evaluation (which is based on technical advice, taking into account the nature of the asset, the estimated usage of the asset, the operating conditions of the asset, past history of replacement, anticipated technological changes, manufacturers warranties and maintenance support, etc.) that the useful lives of the assets as considered by the company reflect the periods over which these assets are expected to be used.

The carrying values of property, plant and equipment are reviewed for impairment when events or changes in circumstances indicate that the carrying value may not be recoverable.

The residual values, useful life and depreciation method are reviewed at each financial year-end to ensure that the amount, method and period of depreciation are consistent with previous estimates and the expected pattern of consumption of the future economic benefits embodied in the items of property, plant and equipment.

2.8 Capital work-in-progress

Capital work-in-progress are carried at cost, comprising direct cost, related incidental expenses and attributable borrowing cost.

2.9 Impairment of PPE :

Property, plant and equipment with finite life are evaluated for recoverability whenever there is any indication that their carrying amounts may not be recoverable. If any such indication exists, the recoverable amount (i.e. higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the cash-generating unit (CGU) to which the asset belongs.

If the recoverable amount of an asset (or CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or CGU) is reduced to its recoverable amount. An impairment loss is recognized in the Statement of Profit and Loss.

2.10 Income tax

Income tax expense comprises current tax expense and the net change in the deferred tax asset or liability during the year. Current and deferred taxes are recognised in Statement of Profit and Loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity, respectively.

Current tax: Current tax is measured at the amount of tax expected to be payable on the taxable income for the year as determined in accordance with the provisions of the Income Tax Act, 1961. Current tax assets and current tax liabilities are offset when there is a legally enforceable right to set off the recognized amounts and there is an intention to settle the asset and the liability on a net basis.

Deferred tax: Deferred income tax is recognized using the Balance Sheet approach. Deferred income tax assets and liabilities are recognised for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount, except when the deferred income tax arises from the initial recognition of an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profit or loss at the time of the transaction.

Deferred tax assets are recognised only to the extent that it is probable that either future taxable profits or reversal of deferred tax liabilities will be available, against which the deductible temporary differences, and the carry forward of unused tax credits and unused tax losses can be utilized. The carrying amount of a deferred tax asset is reviewed at the end of each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilized.

Deferred tax assets and liabilities are measured using the tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred tax asset is realized or the deferred tax liability is settled. Deferred tax assets and liabilities are offset when there is a legally enforceable right to set current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority.

2.11 Operating Leases Including Investment Properties

The Company assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

NOTES ON FINANCIAL STATEMENTS

As a lessee

a) Right-of-use assets

The Company recognises right-of-use assets at the commencement date of the lease (i.e. the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets.

If ownership of the leased asset transfers to the Company at the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

The right-of-use assets are also subject to impairment. Refer to note 2.9 for accounting policies on impairment of non financial assets.

b) Lease liabilities

At the commencement date of the lease, the Company recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments primarily comprise of fixed payments.

In calculating the present value of lease payments, the Company uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made.

c) Short-term leases and leases of low value assets

The Company applies the short-term lease recognition exemption to its short-term leases of office spaces and certain equipment (i.e. those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases of office equipment that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

As a lessor

Leases in which the Company does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income arising is accounted for on a straight-line basis over the lease terms. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income.

2.12 Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

2.13 Provisions and Contingent Liabilities

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance Sheet date.

If the effect of the time value of money is material, provisions are discounted to reflect its present value using a current pre-tax rate that reflects the current market assessments of the time value of money and the risks specific to the obligation. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

2.14 Inventories

Inventories are valued at lower of cost on FIFO basis and net realisable value after providing for obsolescence and other losses, where considered necessary. Cost includes all charges in bringing the goods to their present location and condition, including octroi and other levies, transit insurance and receiving charges. Work-in-progress and finished goods include appropriate proportion of overheads and, where applicable, GST. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

2.15 Non-derivative financial instruments

Classification

The classification is done depending upon the Company's business model for managing the financial assets and the contractual terms of the cash flows.

For assets classified as 'measured at fair value', gains and losses will either be recorded in profit or loss or other comprehensive income, as elected. For assets classified as 'measured at amortized cost', this will depend on the business model and contractual terms of the cash flows.

NOTES ON FINANCIAL STATEMENTS

Initial Measurement and Recognition

Financial assets and liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument. Financial assets and liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value measured on initial recognition of financial asset or financial liability.

a. Financial assets – Subsequent measurement

Financial assets at amortised cost: Financial assets are subsequently measured at amortised cost if these financial assets are held within a business whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at fair value through other comprehensive income (FVTOCI): Financial assets are measured at fair value through other comprehensive income if these financial assets are held within a business whose objective is achieved by both collecting contractual cash flows that give rise on specified dates to solely payments of principal and interest on the principal amount outstanding and by selling financial assets.

Financial assets at fair value through profit or loss (FVTPL): Financial assets are measured at fair value through profit or loss unless it is measured at amortised cost or at fair value through other comprehensive income on initial recognition. The transaction costs directly attributable to the acquisition of financial assets and liabilities at fair value through profit or loss are immediately recognised in profit or loss.

Investments are measured at fair value changes recognised in the Statement of Profit and loss. However, income on such investments are also recognised in the Statement of Profit & loss when the company's right to receive payment is established.

b. Financial liabilities - Subsequent measurement

Financial liabilities are measured at amortised cost using the effective interest method. The measurement of financial liabilities depends on their classification, as described below:

Loans and borrowings: After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost on accrual basis.

Composite financial instrument: The fair value of the liability portion of an optionally convertible bond is determined using a market interest rate for an equivalent non-convertible bond. This amount is recorded as a liability on an amortised cost basis

until extinguished on conversion or redemption of the bonds. The remainder of the proceeds is attributable to the equity portion of the compound instrument. This is recognised and included in shareholders' equity.

Impairment of financial assets

The Company assesses on a forward-looking basis, the expected credit losses associated with its financial assets carried at amortised cost for e.g., debt securities, deposits, trade receivables and bank balances; and lease receivables. The impairment methodology applied depends on whether there has been a significant increase in credit risk and if so, assess the need to provide for the same in the Statement of Profit and Loss.

The Company follows 'simplified approach' for recognition of impairment loss allowance on trade receivables and all lease receivables.

The application of simplified approach does not require the Company to track changes in credit risk. Rather, it recognises impairment loss allowance based on lifetime expected credit losses (ECL) at each reporting date, right from its initial recognition.

For recognition of impairment loss on other financial assets and risk exposure, the Company determines whether there has been a significant increase in the credit risk since initial recognition. If credit risk has not increased significantly, 12-month ECL is used to provide for impairment loss. However, if credit risk has increased significantly, lifetime ECL is used. If, in a subsequent period, credit quality of the instrument improves such that there is no longer a significant increase in credit risk since initial recognition, then the entity reverts to recognising impairment loss allowance based on 12-month ECL.

Lifetime ECL are the expected credit losses resulting from all possible default events over the expected life of a financial instrument. The 12-month ECL is a portion of the lifetime ECL which results from default events that are possible within 12 months after the reporting date.

ECL is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the entity expects to receive (i.e., all cash shortfalls), discounted at the original EIR. When estimating the cash flows, an entity is required to consider all contractual terms of the financial instrument over the expected life of the financial instrument.

ECL impairment loss allowance (or reversal) recognised during the period is recognised as income/expense in the Statement of Profit and Loss. This amount is reflected under the head 'other expenses' in the Statement of Profit and Loss. The Balance Sheet presentation for various financial instruments is described below:

- Financial assets measured at amortised cost, revenue receivables and lease receivables: ECL

is presented as an allowance, i.e., as an integral part of the measurement of those assets in the Balance Sheet. The allowance reduces the net carrying amount. Until the asset meets write-off criteria, the Company does not reduce impairment allowance from the gross carrying amount.

For assessing increase in credit risk and impairment loss, the Company combines financial instruments based on shared credit risk characteristics with the objective of facilitating an analysis that is designed to enable significant increases in credit risk to be identified on a timely basis.

For debt instruments at fair value through OCI, the Company applies the low credit risk simplification. At every reporting date, the Company evaluates whether the debt instrument is considered to have low credit risk using all reasonable and supportable information that is available without undue cost or effort. In making that evaluation, the Company reassesses the internal credit rating of the debt instrument.

However, in certain cases, the Company may also consider a financial asset to be in default when internal or external information indicates that the Company is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Company. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Derecognition

A financial liability is derecognised when the obligation specified in the contract is discharged, cancelled or expires.

c. Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in financial statements if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

2.16 Borrowing costs

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale otherwise to be charged to the statement of profit and loss. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation. Other borrowing costs are expensed in the period in which they are incurred.

2.17 Employee Benefits

Employee benefits consist of contribution to employee's state insurance, provident fund, gratuity fund and compensated absences.

Post-employment benefit plans

Defined Contribution plans

Contributions to defined contribution schemes such as employees' state insurance, labour welfare fund, employee pension scheme etc. are charged as an expense based on the amount of contribution required to be made as and when services are rendered by the employees. Company's provident fund contribution is made to a government administered fund and charged as an expense to the Statement of Profit and Loss. The above benefits are classified as Defined Contribution Schemes as the Company has no further defined obligations beyond the monthly contributions.

Defined benefit plans

The Company operates defined benefit plan in the form of gratuity and compensated absence. The liability or asset recognised in the balance sheet in respect of its defined benefit plans is the present value of the defined benefit obligation at the end of the reporting period. The defined benefit obligation is calculated annually by actuaries using the projected unit credit method. The present value of the said obligation is determined by discounting the estimated future cash out flows, using market yields of government bonds that have tenure approximating the tenures of the related liability.

The interest expenses are calculated by applying the discount rate to the net defined benefit liability or asset. The net interest expense on the net defined benefit liability or asset is recognised in the Statement of Profit and loss.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognised in the period in which they occur, directly in other comprehensive income. They are included in retained earnings in the Statement of Changes in Equity and in the Balance Sheet.

Changes in the present value of the defined benefit obligation resulting from plan amendments or curtailments are recognised immediately in profit or loss as past service cost.

The classification of the company's net obligation into current and non-current is as per the actuarial valuation report.

2.18 Earnings per share (EPS)

Basic EPS is computed by dividing the profit or loss attributable to the equity shareholders of the Company by the weighted average number of Ordinary shares outstanding during the year. Diluted EPS is computed by adjusting the profit or loss attributable to the ordinary equity shareholders and the weighted average number of ordinary equity shares, for the effects of all dilutive potential Ordinary shares.

As required by Section 102 of the Companies Act, 2013 ("Act"), the following explanatory statement sets out all material facts relating to the business mentioned under Item No. 4 to 6 of the accompanying Notice.

Item No. 4

In accordance with the provisions of Section 148 of the Companies Act, 2013 read with the Companies (Audit and Auditors) Rules, 2014 the remuneration payable to the Cost Auditors has to be ratified by the members of the Company.

The Board on the recommendation of the Audit Committee has approved the remuneration of the Cost Auditors to conduct the audit of the cost records of the Company for the financial year 2024-25 as mentioned in the resolution set out at Item No.4 of the notice.

Accordingly, consent of the members is sought for passing an Ordinary Resolution as set out at this item of the Notice for ratification of the remuneration payable to the Cost Auditors for the financial year 2024-25.

The Board recommends the Resolution set out at Item No.4 for your approval.

Item No. 5

The Company had received a request letter dated 8th August, 2024 from Aircon Systems (India) Private Limited belonging to the promoter group of the Company for re-classification from the 'promoter and promoter group' category to 'public' category shareholder in accordance with Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations"):

Aircon Systems (India) Private Limited has in their request letter informed the Company that they are neither a part of the Board of Directors of the Company nor hold any Key Managerial Position through their authorised representative in the Company. Further, they had confirmed in their letter that they do not participate in the management of the Company in any manner or capacity and do not have any special rights in the Company through formal or informal arrangements, including any shareholder agreement.

Pursuant to the provisions of Regulation 31A(3)(b) of the Listing Regulations, Aircon Systems (India) Private Limited in their request letter, has confirmed that along with the persons related to them:

- (a) do not hold more than 10% of the voting rights in the Company;
- (b) do not exercise control over the affairs of the Company directly or indirectly;
- (c) do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
- (d) are not represented on the Board (including not having a nominee director) of the Company;
- (e) are not acting as Key Managerial Personnel in the Company;
- (f) are not 'willful defaulter' as per the Reserve Bank of India Guidelines; and
- (g) are not fugitive economic offenders.

In view of the above, and on the basis of the rationale and the confirmations received from Aircon Systems (India) Private Limited, the Board of Directors of the Company, at its meeting held on 14th August, 2024, analyzed the request made by Aircon Systems (India) Private Limited and in compliance with Regulation 31A of the Listing Regulations, approved the request for re-classification, inter alia subject to approval by the members, the stock exchanges where the shares of the Company are listed namely BSE Limited and National Stock Exchange of India Limited (collectively "Stock Exchanges"), and/or such other approval, if any as may be necessary in this regard.

As required under Regulation 31A(8) of the Listing Regulations, the Company has intimated the Stock Exchanges of receipt of reclassification request from Aircon Systems (India) Private Limited on 9th August, 2024 and the extract of the minutes of the meeting of the Board of Directors of the Company approving the re-classification was submitted to the Stock Exchanges on 14th August, 2024.

In accordance with Regulation 31A(3)(a)(iii) of the Listing Regulations, the reclassification of status of a shareholder holding more than one percent of the total voting rights in the Company, from the 'promoter and promoter group' category to the 'public' category, inter alia requires approval of the members of the Company by way of an ordinary resolution. Therefore, the aforesaid request for re-classification of Aircon Systems (India) Private Limited is being placed before the members of the Company for approval by way of an ordinary resolution.

The Company is in compliance with the requirement for minimum public shareholding as required under Regulation 38 of the Listing Regulations, does not have trading in its shares suspended by the Stock Exchanges and does not have any outstanding dues to the Securities and Exchange Board of India, the Stock Exchanges or the depositories.

Further, the promoter(s) seeking reclassification and persons related to them shall not vote to approve such reclassification request.

None of the Directors or key managerial personnel of the Company or their relatives are in any way concerned or interested in the proposed resolution as set out in item No. 5 of the Notice.

The Board of Directors of the Company recommends the resolution as set out in item No. 5 of the Notice for the approval of the members of the Company as an ordinary resolution.

Item No. 6

The objective of adding new Object Clause of the Company is to expand its investment opportunities by including the acquisition, holding, purchase, sale, and dealing in shares, stock, debentures, bonds, obligations, and securities issued or guaranteed by any government, mutual funds, Alternative Investment Funds (AIF), public sector companies, or any other companies globally. This amendment also allows the Company to underwrite these financial instruments and engage within the commodity market, capital market, foreign exchange, and metal market. Additionally, it includes provisions for dealing, trading, and writing futures, options, swaps, and other financial derivatives related to these markets. The proposed amendment aims to broaden the Company's business scope,



allowing it to capitalize on diverse investment opportunities. By participating in both domestic and international markets, the Company can increase revenue streams, manage risks more effectively through diversified investment strategies, and maximize shareholder value.

None of the Directors or key managerial personnel of the Company or their relatives are in any way concerned or

interested in the proposed resolution as set out in item No. 6 of the Notice.

The Board of Directors of the Company recommends the resolution as set out in item No. 6 of the Notice for the approval of the members of the Company as a special resolution.
