We would like to inform you that the Extra-Ordinary General Meeting of the company will be held on 11<sup>TH</sup> October 2023, Wednesday at 12:00 P.M. at the registered office of the company at 209, Rajani Bhuvan, 569 M.G. Road Indore MP 452001 India.

As per Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company offers the remote e-voting facility through Central Depository Service (India) Limited (CDSL) to enable the Members to cast their votes by electronic means on all the resolutions set out in the Notice convening the EGM.

The details required to be given under the Companies Act, 2013 and Rules made thereunder are as follows:

1. Members holding shares either in physical form or in dematerialized form, as on cut-off date i.e. Wednesday 4<sup>th</sup> October 2023 shall be entitled to avail the facility of remote e-voting and voting to be held at EGM on the business specified in the Notice of the Company.
2. Remote e-voting period commence on Sunday 8<sup>th</sup> October 2023, 9:00 A.M. (IST) and end on Tuesday 10<sup>th</sup> October 2023, 5:00 P.M (IST) and thereafter, the remote e-voting module shall be disabled by CDSL.
3. Details of the manner of casting of votes are to be provided in the Notice of EGM and will be posted on the website of the Company [www.sanchayinvest.in](http://www.sanchayinvest.in).
4. The Member who have cast their vote by remote e-voting may attend the meeting but shall not be entitled to cast their vote again and members attending the meeting who have not cast their vote through e-voting shall be able to vote at EGM through remote e-voting to be provided at the EGM.
5. Any person who becomes a member of the Company after dispatch of Notice and holds shares as on cut-off date may obtain the sequence number from the Company's Registrar and Share Transfer Agent at the address mentioned in the Notice.
