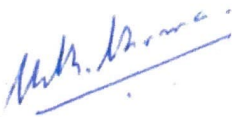

इशानला एक न्याय, हार्दिक पांड्याला दुसरा IPL खेळण्यासाठी रणजी खेळणे बंधनकारक नाही नवी दिल्ली, दि. १४ (वृत्तसंस्था) : इशान किशन कुटे गायब झाल्या... याचा शोध सध्या लागणे अवघड झालं आहे. दक्षिण आफ्रिका दौऱ्यावरून मानसिक थकवा असल्याचे सांगून इशान मायदेशात परतला तो कोणाच्या संपर्कातच नाही. भारतीय संघात परतण्यासाठी त्याला देशांतर्गत क्रिकेट खेळण्याचा अप्रत्यक्ष सर्वात मुख्य प्रशिक्षक राहुल द्रविड यांनी दिला होता. पण, त्याकडे इशानने काणाडोळा केल्याचे पाहायला मिळाले. झारखंडच्या रणजी करंडक स्पर्धेतील पाच सामन्यांमध्ये इशान कुटेच दिसला नाही. सूर्वांच्या माहितीनुसार तो मागील महिनाभर बडोदा येथील किरण मोरे यांच्या अकादमीत कुणाल व हार्दिक या पांड्या बंधुसोबत आयपीएलसाठी तयारी करतोय. इशानच्या या वागण्याने संतापलेल्या BCCI ने आयपीएल खेळायची असेल तर रणजी करंडक स्पर्धेतील किमान २-३ सामने खेळा असा फतवा काढल्याचे समजतेय. इशानसह कुणाल पांड्या व दिपक चहर यानाही हा सल्ला दिला गेला आहे. पण, यातून हार्दिक पांड्याला सूट दिली गेली आहे. तो सध्या पर्सनल ट्रेनिंग घेत आहे. वन डे वर्ल्ड कप स्पर्धेत झालेल्या दुखापतीनंतर तो आंतरराष्ट्रीय मालिकांना मुकलेला आहे आणि तो थेट आयपीएलमधून पुनरागमन करण्याचे बोलले जातेय. हार्दिकसाठी दुसरा न्याय का, असा सवाल जेव्हा BCCI अधिकाऱ्याला केला गेला, तेव्हा त्यांनी त्यामागचं कारण सांगितलं. एका अधिकाऱ्याने टाईम्स ऑफ इंडियाला सांगितले की, "आम्ही हार्दिक पांड्याचे प्रकरण समजू शकतो कारण त्याचे शरीर लाल-बाल क्रिकेटची कठोरता स्वीकारू शकत नाही. तो कसोटी क्रिकेटचा भार सहन करू शकत नाही आणि टीम इंडियाला तो आयपीएल स्पर्धेसाठी तंदुरुस्त हवा आहे."

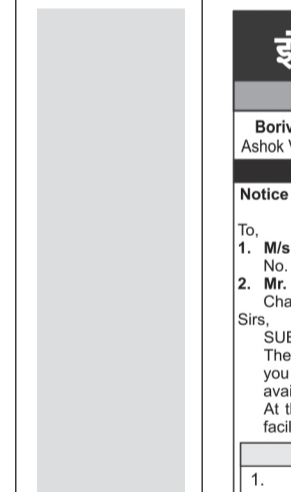

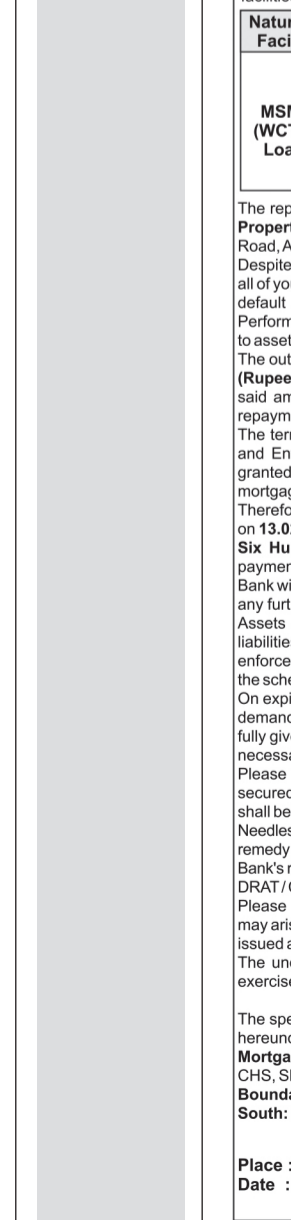
