► From P 1 While the number of women from Kerala is 2,011, much larger states like Uttar Pradesh and West Bengal have very few women travelling without a man—99 and 39, respectively. ► From P 1 His mother, Ujjwala Tiwari, was all-rude in hospital for her treatment. She received a call from home that Rohit was bleeding from nose and went home with an ambulance. Rohit was declared 'brought dead' at hospital around 5pm," an official said. At the time of the incident, Rohit's brother Siddharth, wife Apoorva and other personal assistants were present in the house. During the inquiry cops found some discrepancies in the statements of the family members which are being analysed. Doctor suspects the timing of death to be around 1am-3.30am. A rigor mortis had set in when he was taken to the Max Hospital.

SEQUENCE OF EVENTS

- Monday night, 11.30pm:** Rohit Shekhar returned to Delhi from Uttarakhnad after casting his vote. Went to sleep after taking some medicines
- Tuesday, 4.30pm:** Max Hospital, Saket, received an emergency call from Rohit's residence in Defence Colony that he was bleeding from nose
- His mother, Ujjwala Tiwari, was already in the same hospital for her treatment**
- She also received a similar call after which she rushed home in an ambulance**
- 5pm:** Doctors declared Rohit 'brought dead' after he was taken to the hospital

Household helps told the cops that after returning from Kotdwar, Rohit had refused to have dinner and went to his bedroom to sleep. He had slept 11pm the next day, during which neither his wife, mother or brother had tried to wake him up. They would be quizzed regarding this as well. The air-conditioner in his room was also turned on. He was in his nightwear when the body was recovered.
