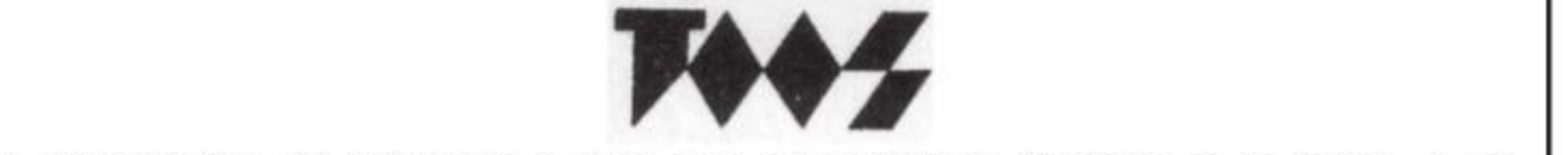

तंबाखुजन्य पदार्थावर कायमची बंदी शक्य नाही

मद्रास उच्च न्यायालयाचा निर्वाळा

चेन्नई, दि. २५ - तंबाखुजन्य पदार्थावर कायमस्वरूपी बंदी आणणाऱ्या कायदा केंद्र व राज्य सरकारकडे नाही. त्यामुळे राज्य शासन तंबाखु व तंबाखुजन्य पदार्थावर कायमस्वरूपी बंदी आणू शकत नाही, असा निर्वाळा मद्रास उच्च न्यायालयाने दिला आहे.

न्या. आर. सुब्रमण्यन व न्या. के. कुमारिंग बाबू यांच्या खंडपीठाचे हा निकाल दिला. तामिळनाडूमध्ये गुटखा, पान मसाला विक्रीवर बंदी आणणाऱ्या अधिसूचना न्यायालयाने रद्द केली. तामिळनाडू येथील अन्न व औषध प्रशासनाने ही अधिसूचना काढली होती. त्यासारखे गुटखा उत्पादन, विक्री व वाहतुकीला तामिळनाडूमध्ये एकवर्षासाठी बंदी घालण्यात आली होती. मात्र अन्न व औषध प्रशासन असा प्रकार कायमस्वरूपी निबंध लादू शकत नाही, असा निर्वाळा न्यायालयाने दिला.

याप्रकरणी जयाविलास तंबाखु विक्रेते यांनी मद्रास उच्च न्यायालयात याचिका केली होती. गुटखा बंदीची एकदा जारी केलेली अधिसूचना वारंवार लागू केली जात आहे. तंबाखु व तंबाखुजन्य पदार्थां हे अन्न पदार्थांच्या व्याख्येत येत नाहीत, त्यामुळे अन्न सुरक्षा कायदांतर्गत त्यावर बंदी

आणली जाऊ शकत नाही. त्यामुळे ही अधिसूचना रद्द करावी, अशी मागणी याचिकेत करण्यात आली होती.
