इंदौर। राहुल गांधी नगर में रहने वालीं ३५ वर्षीय मधु पत्नी छगनलाल यादव ने छोटी बहन ज्योति चौहान और संतोष के खिलाफ मारपीट व हत्या की धमकी का केस दर्ज कराया है। लसूड़िया थाना पुलिस ने बताया कि आरोपित बहन और उसका पति मां नारायणी के मकान में मधु और मां के साथ कई सालों से रह रहे हैं। मंगलवार को दोनों आरोपित आए और मधु के घर में रहने की बात को लेकर गालियां देने लगे। कहा कि अब से इस मकान में वे ही रहेंगे। गालियां देने से मना किया तो दोनों मारपीट करने लगे। इसके बाद छोटी बहन ने डंडा उठाया और सिर पर मार दिया। डंडा लगते ही सिर से खून निकलने लगा। मधु वहां से जाने लगी तो कहा कि आज के बाद यदि वापस आई तो जान से खत्म कर देंगे। मामले में पुलिस ने आरोपितों के खिलाफ मारपीट का केस दर्ज किया है।

इंदौर। महिला थाने में एक नवविवाहिता ने अपने पति और ससुराल वालों के खिलाफ दहेज यातना का केस दर्ज करवाया है। पीड़िता का आरोप है कि शादी के दूसरे ही दिन से उससे मोटरसाइकिल और ५००००० की मांग की जाने लगी थी। उसका पति गैरेज मैकेनिक है गैरेज खोलने के लिए पैसों की मांग कर रहा था । महिला ने बच्ची को जन्म दिया तो मासुम बच्ची को उसके पिता ने रख लिया जबकि पत्नी को घर से निकाल दिया । महिला थाना प्रभारी ज्योति शर्मा के अनुसार पीड़िता का नाम रुखसार खान निवासी काजी की चाल मालवा मिल मस्जिद के पास है । उसकी शिकायत पर उसके पति परवेज खान ,सास रुखसाना, ससुर नासिर ,सहित नाहीद सभी निवासी इटावा जिला देवास पुष्प कुंज कॉलोनी के खिलाफ अलग-अलग धाराओं में केस दर्ज किया गया है । पीड़िता ने बताया कि 3 साल पहले उसकी शादी परवेज से हुई थी। उसके पिता ने हैसियत के मुताबिक उसे दहेज भी दिया था। शादी के अगले ही दिन से उसका पति और ससुराल वाले मोटरसाइकिल और ५००००० की मांग करने लग गए थे । पति का कहना था कि उसे नया गैरेज खोलना है , इसलिए पैसों की जरूरत है। रुखसार का कहना है कि उसने पहले बेटे को जन्म दिया बाद में उसको बेटी हुई तो ससुराल वालों ने बेटी को अपने पास ही रख लिया और उसे घर से निकाल दिया ६ माह से वह अपने

स्थित एक दवा कंपनी में सिक्योरिटी गार्ड द्वारा कंपनी कर्मचारी को गुटखा-पाउच ले जाने से मना किया गया तो बाद में उसने गार्ड के साथ मारपीट की। जानकारी के अनुसार फार्मा जोन स्थित कंपनी ल्युपिन फार्मा गेट पर काम पर जाते समय आरोपित गिलप्रट अपने साथ गुटखा-पाउच लेकर अंदर जा रहा था, जो कंपनी के नियमानुसार गलत था। इस दौरान सिक्योरिटी गार्ड शिवा पडोले ने उसे मना किया। बहस होने पर गिलप्रट को काम पर नहीं जाने दिया गया। इसके बाद वह अपने साथियों के साथ कंपनी पहंचा और गेट के सामने ही शिवा की पिटाई कर दी। पलिस ने फरियादी शिवा पडोले निवासी पीथमपुर की रिपोर्ट पर आरोपित गिलप्रट टोटपे पिता एमदान के खिलाफ प्रकरण दर्ज कर लिया है।

## कार पर लगे फास्ट टैग से गिरफ्त में आया गिरोह

इंदौर। इंदौर जीआरपी (रेलवे पुलिस) ने ऐसे गिरोह को पकड़ा है जो ट्रेनों में लूटपाट-चोरी करता था। गिरोह के सदस्य आउटर पर लगे इलेक्ट्रॉनिक टूल में सिक्का फंसा कर सिग्नल रेड कर देते थे। जैसे ही ट्रेन रुकती दो डिब्बे के नीचे घुस कर डिब्बों को जोड़ने वाली स्थान से प्रवेश कर जाते थे। बदमाशों से लाखों रुपये कीमत का सोना और नकदी मिली है। पुलिस ने आरोपितों को गुजरात पुलिस के सुपुर्द कर दिया है।

एसपी(जीआरपी) किरण केरकेट्टा के मुताबिक 26 जून को भिंड-रतलाम ट्रेन में मक्सी में लूट की वारदात हुई थी। नकाबपोश बदमाशों ने ट्रेन में घुसकर यात्रियों को पीटा और जेवर व नकदी लेकर भाग गए। जानकारी जुटाने पर पता लगा कि इसी प्रकार से महाराष्ट्र, गुजरात, राजस्थान में भी घटनाए हुई हैं। तत्काल सभी तीनों राज्यों की पुलिस सक्रिय हुई और मंगलवार रात आरोपित राहुल चाइना वाल्मिकी निवासी तिलकनगर टोहना(हरियाणा), सन्नी पिता पुरण वाल्मिकी निवासी राजनगर टोहना, छोटा उर्फ सुखबीर पिता महेंद्रसिंह निवासी राजनगर और दीपक पिता महेंद्र निवासी पंजाबी कालोनी को गिरफ्तार कर लिया। आरोपितों से 300 ग्राम सोना, 500 ग्राम चांदी जब्त की गई है।

एएसपी(जीआरपी) राकेश खाका के मुताबिक आरोपितों ने तकनीकी का फायदा उठाया। आउटर के आसपास पटरियों पर एक इलेक्ट्रॉनिक बॉक्स लगा होता है। आरोपित उसमें सिक्का फंसाकर सिग्नल रेड कर देते थे। सिग्लन रेड होते ही ट्रेन को रुकना पडता था। एक आरोपित डिब्बे के नीचे घुसता और जिस जगह दो डिब्बों को जोड़ने के लिए लोहे का पतरा लगा होता वहां से डिब्बे में अंदर चले जाता था। आरोपित महिलाओं. बच्चों को हथियारों दिखाकर धमकाते और उनका सारा सामान लूट कर फरार हो जाते थे। इस तरह अभी तक छह घटनाएं कर चुके है।

इंदौर-उज्जैन क्षेत्र में हमारी जानकारी के मुताबिक सिर्फ आठ महिला पुलिस कर्मी रेलवे पुलिस में पदस्थ है। ऐसे में जब गाड़ियों की संख्या बढ़ेगी तो महिला यात्रियों की सुरक्षा के इंतजाम स्टाफ की कमी के बीच करना बड़ी चुनौती है। हमने आइजी को भेजे ज्ञापन में पुलिस बल में नई भर्ती की मांग भी रखी है। कारोबार बढ़ने के साथ व्यापारी

## द्रेन में बढ़ रहे अपराध, रेलवे आइजी से सुरक्षा बढ़ाने की मांग

लाकडाउन के बाद से ट्रेन में मुसाफिरों के साथ घटित होने वाले अपराधों की संख्या बढ़ी है। रेलवे एसपी किरणलता केरकेटा के सामने व्यापारियों और रेल उपभोक्ता सलाहकार समिति के सदस्यों ने इस बारे में चिंता प्रकट करते हुए यात्री गाड़ियों में सुरक्षा बढ़ाने की मांग की। समिति सदस्य ने रतलाम मंडल के रेलवे पुलिस आइजी के नाम ज्ञापन भी सौंपा। रेल उपभोक्ता सलाहकार समिति के सदस्य संजय बाकलीवाल, इंदौर लोहा व्यापारी एसोसिएशन के पूर्व ट्रस्ट अध्यक्ष जितेंद्र कटारिया, आशीष जैन व अमजद बेलिम समेत कारोबारी रेलवे एसपी से ट्रेन में बढ रही अपराध की घटनाओं पर चर्चा करने पहुंचे। कटारिया ने कहा कि बीते एक माह के दौरान परिक्षेत्र यानी इंदौर-उज्जैन क्षेत्र में ही ट्रेन में अपराध की सात घटनाएं प्रकाश में आ चुकी है। इनमें एक युवती की चलती ट्रेन में हत्या जैसा गंभीर उपराध भी शामिल हैं। लाकडाउन के दौर में गरीबी, बेरोजगारी बढ़ी है। अब ट्रेनों में यात्रियों की संख्या भी बढ़ रही है। इन परिस्थितियों के मद्देनजर आने वाले दिनों में अपराध और बढ़ सकते हैं। लिहाजा, रेलवे पुलिस को हर गाड़ी में सुरक्षा और गश्त की व्यवस्था करना होगी। इस बारे में हमने रेलवे एसपी से चर्चा की व मांग रखी। यह चिंतनीय है कि रेलवे पुलिस के पास बल की कमी है।

एक से दूसरे शहर में रेल के जरिए यात्रा करेंगे। उनके पास कीमती सामान, नकदी भी होती है। इस स्थिति में असरक्षा का भय व्यापारियों को परेशान कर रहा है। रेलवे एसपी ने क्षेत्र में सुरक्षा कड़ी करने और गश्त बढाने का आश्वासन दिया है।

# Remove pornographic content immediately: **NCW** to Twitter

The National Commission for Women (NCW) has asked the Managing Director of Twitter India to remove all pornographic and obscene content from the platform within a week. NCW chairperson Rekha Sharma also wrote to the Commissioner of Police, Delhi to investigate the matter and take appropriate legal action.

"NCW has taken suo motu cognisance of several profiles on Twitter sharing pornographic content. Chairperson Ms Rekha Sharma has written to Managing Director, Twitter India, for immediately removing all such pornographic and obscene content from the platform within a week," the women's panel said in a state-

ment. Upon receiving a similar complaint earlier, the commission had brought it to Twitter's notice for immediate action. However, no action was reportedly taken by the platform, the NCW said. The commission is disturbed with the fact that despite knowing of the availability of such banned content which not only violates Indian laws but also Twitter's own policy, no action has been taken till date towards removing them.

"The commission has shared with Twitter details of a few profiles sharing pornographic content on Twitter and has directed to remove all such content in one week. The platform has also been asked to communicate action taken within 10


