MHA restores FCRA licence of MoC, can receive foreign fundings again

PRESS TRUST OF INDIA New Delhi, January 8

THE UNION HOME ministry has restored the Foreign Contribution Regulation Act (FCRA) registration of the Missionaries of Charity, days after revoking it following some "adverse inputs".

A home ministry official said that with the restoration of the FCRA licence, the Kolkata-based famed organisation will be able to receive foreign fundings and can also spend the money lying in the banks.

The Missionaries of Charity (MoC) is a Catholic religious congregation established in 1950 by Nobel laureate Mother Teresa to help the poor and destitute,

The Missionaries of Charity did not officially comment on the report when asked about it,



but a top official, who requested anonymity, confirmed to *PTI* that the MHA indeed restored FCRA licence from January 7 and "we are happy with the development".

"Our service for the poor and distressed continued with the help of our donors and well-wishers in the country when the FCRA registration

was not renewed. In the early parts of new year the news comes as a relief, no doubt," the official told PTI in Kolkata.

On December 27, the home ministry had said that it cancelled the FCRA licence of Missionaries of Charity after receiving some "adverse inputs".

It also said that it did not freeze any account of the Mis-

sionaries of Charity but the State Bank of India informed it that the NGO itself sent a request to the bank to freeze its accounts.

After the matter became public, the Opposition, including West Bengal chief minister Mamata Banerjee and the Congress, slammed the government for the alleged "freezing" of the MoC's bank accounts.

Following the home ministry action, Odisha chief minister Naveen Patnaik had directed to all district collectors to ensure that no unit of the Missionaries of Charity, operating in the state, should face any financial crisis and if necessary use the chief minister's relief fund to

Patnaik had also released over ₹78 lakh to the Missionaries of Charity to run over a dozen institutes in the state.

CSB Bank MD & CEO takes early retirement

CSB BANK IN a regulatory filing said on Saturday that CVR Rajendran, managing director & CEO of the bank, has decided to take an early retirement from the post to take care of his health under the advice of his physicians.

Rajendran will continue to lead the Bank till March 31, 2022. CSB sources further said that the Board has decided to constitute a search committee to identify and evaluate candidates from internally or externally for the position of MD & CEO. It has also been decided to engage an independent executive search firm in this connection.

His decision to move on from the post of MD & CEO has been approved by the board of directors in a meeting held on Saturday. Rajendran has been MD & CEO since December 9, 2016, and the current term is up to December 8, 2022.

He was instrumental in bringing ₹1,208 crore of primary capital in CSB Bank from FIH Mauritius Investments (a subsidiary of Fairfax India Holdings) and also led CSB Bank through a successful initial public offering.

Equitas Holdings to fully divest stake in subsidiary ETPL ahead of merger with Equitas SFB



New Delhi, January 8

EQUITAS HOLDINGS WILL divest its entire stake in subsidiary Equitas Technologies (ETPL) as part of the requirement for the merger with Equitas Small Finance Bank (ESFB). As part of the RBI's licens-

ing conditions, being the promoter of ESFB, the boards of Equitas Holdings and ESFB had in July 2021 approved the scheme of amalgamation between them. According to this scheme, all

the assets held by Equitas Holdings, including its investments in ETPL, have to be transferred to and vested in ESFB. "Since ETPL is not engaged in financial services, the company is required to fully divest its investment in ETPL. Accordingly, the board of directors in its meeting held on January 7, 2022, approved sale of its entire shareholding in the company's subsidiary, ETPL," Equitas Holdings said in a regulatory filing on Saturday. Equitas Holdings (EHL) has

two subsidiaries — ESFB and ETPL.The latter is engaged in the business of freight aggregation. Equitas Holdings said it has appointed SBI Capital Markets (SBICAPS) to advise on the strategic buyout and/or stake sale of ETPL.

SBICAPS is in the process of undertaking a public auction process to identify potential buyer(s) and complete the transaction, it added.

The RBI approved the merger between the promoter and subsidiary company in July last year.

Oberoi Realty Q3 sales bookings jump twofold to ₹1,965 crore

MUMBAI-BASED OBEROI **REALTY** has reported over twofold jump in its sales bookings at ₹1,965 crore for the third quarter ended December on higher demand.

In regulatory filings on Friday, Oberoi Realty has shared a summary of bookings made by the company for the third quarter of this financial year (on a consolidated basis). Its sales bookings rose to

₹1,965 crore during the

October-December quarter from ₹971 crore in the yearago period. Oberoi Realty sold 371 units during the last quarter

against 234 units a year ago. During the first nine months of 2021-22, the company's sales bookings jumped more than two-fold to ₹2,964 crore from ₹1,323 crore in the

year-ago period. It sold 610 units during the April-December period of 2021-22 as against 284 units in the same period of the



last fiscal.

Earlier this week, Macrotech Developers reported a 40% increase in its sales bookings to ₹2,608 crore during the third quarter of this fiscal from ₹1,862 crore in the year-ago period.

According to property consultants, housing demand across major 7-8 cities has recovered sharply after the second wave of the Covid pandemic that hit sales during the April-June period last year.

The market share of trusted real estate developers in the overall housing sales is gradually increasing as homebuyers have become risk-averse.

As per reports of various consultants, housing sales in the 2021 calendar year increased sharply by 50-70% from the previous year.

However, sales are yet to reach the 2019 pre-Covid



THE UNION HOME ministry has restored the Foreign Contribution Regulation Act (FCRA) registration of the Missionaries of Charity, days after revoking it following some "adverse inputs".

A home ministry official said that with the restoration of the FCRA licence, the Kolkata-based famed organisation will be able to receive foreign fundings and can also spend the money lying in the banks.

The Missionaries of Charity (MoC) is a Catholic religious congregation established in



Mother Teresa to help the poor

and destitute, The Missionaries of Charity did not officially comment on the report when asked about it, but a top official, who requested anonymity, confirmed to PTI that the MHA indeed restored FCRA licence from January 7 and "we are happy with the development".

"Our service for the poor and distressed continued with the help of our donors and well-wishers in the country when the FCRA registration was not renewed. In the early parts of new year the news comes as a relief, no doubt," the official told PTI in Kolkata.

On December 27, the home ministry had said that it cancelled the FCRA licence of Missionaries of Charity after receiving some "adverse inputs".

It also said that it did not freeze any account of the Missionaries of Charity but the State Bank of India informed it that the NGO itself sent a request to the bank to freeze its accounts.

On December 27, the home ministry had said that it cancelled the FCRA licence of Missionaries of Charity after receiving some "adverse inputs".

It also said that it did not freeze any account of the Missionaries of Charity but the State Bank of India informed it that the NGO itself sent a request to the bank to freeze its accounts.
