Guarding against market distortions

The Competition (Amendment) Bill 2022, tabled in Parliament on August 5, seeks to attune the country's twodecades-old anti-trust laws and systems to the changing market realities. Certain regulatory loopholes have been plugged and the regulator's remit has been suitably enhanced. The Bill also proposes to ease procedures and fast-track regulatory decisions. FE **examines** the key provisions in the Bill.



Why the Competition Amendment Bill 2022? The objectives are to ease regulatory compliance &

factor new market realities into the competition law, taking cue from global trends. Review of events like M&As by the Competition Commission of India will be subject to compressed time-lines. Penalties will be determined in a more rational manner and procedures simplified further.

How is "control" proposed to be re-defined?

The Competition Act, 2002 does not provide for a qualitative test for "control." The Bill seeks to include "material influence" as the lowest level of "control" that a firm could have on the affairs and management of another, apart from shareholding, special rights, board representation, structural/financial arrangements etc.

What is the settlement mechanism proposed?

In regard to contraventions of certain anti-competitive agreements and abuse of dominance charges, an application for settlement may be filed after receipt of investigation report and before passing of final order by the CCI. The commission may determine the norms for computing settlement amounts. The NCLAT will not entertain appeals against CCI orders under the settlement mechanism.

What are the changes to the appealing and penalty

The Bill says 25% of the penalty shall be deposited before filing an appeal with the Appellate Tribunal. This will guard against frivolous appeals. Any CCI order declaring a combination as void ab initio can be challenged in the Appellate Tribunal. Penalty for making a false statement will be hiked to ₹5 crore from ₹1 crore. As for gun-jumping – non-furnishing of information on combinations – the penalty will be 1% of the total turnover or assets or value of transaction, whichever is higher.

asset value and turnover may not suffice to ensure that all combinations (M&A deals) that could have appre-ciable adverse effect on competition go through regulatory scrutiny. M&A deals between high-tech and digital firms, for instance, could potentially disrupt competition even as these firms don't own much physical assets in the market concerned and have turnovers below the thresholds defined. The Bill therefore proposes that all deals worth over ₹2,000 crore be subject to the CCI's prior approval if the firms have "substantial business operations" in India.

How is 'relevant product market' proposed to be redefined?

The concept of 'relevant market' in the extant Act comprises 'relevant product market' and 'relevant geographic market'. The Bill seeks to include 'supply-side substi-tutability' in relevant product market, besides 'consumer-side substitutability'.

Equitas SFB readies for digital push

EQUITAS SMALL FINANCE Bank is planning to launch several digital initiatives on top of its current infrastructure including merchant current account, insurance-tech platform and digital personal loans, Murali Vaidyanathan, the bank's country head of branch banking, lia-

bilities, products and wealth said in an interaction. The lender is in the process of development and integration of some of the products and expects to start rolling them out in 2023, he added. "We want to take that space

of leveraging digital and technology for the growth and prosperity of the bank as an approach,"he said. Currently, the bank's liability

side is entirely driven through a digital product 'Selfe', through which customer can open an account remotely. The bank also has tie-ups with fintech startups such as NiyoX and Freo Save, through which the bank receives deposits from investment-centricand first-time borrowers. The lender is also currently in the final stages of concluding partnerships with two more fintechs to raise more deposits, he said.

Through the merchant current account platform, the bank is planning to increase the current account deposit base, which is at a lower side as of now. As of June 30, the current account deposits of the bank stood at 3% of the total deposit base. The bank aims to ramp up its current account deposits through the new addition, where any merchant can open a digital current account.

Secondly, the bank will operate its insurance business through an open architecture platform and will offer life, health and general insurance products to its customers. The lender has tied up with three insurers in each bucket including players such as ICICI Group,

HDFC Ergo and Reliance General Insurance. Thirdly, the bank has also launched digital personal loans, through which customers can transact remotely. Another major initiative the

bank is planning is launch of its own credit cards and the project is at an initial stage, Vaidyanathan said, without divulging further details. The bank has partnered with HDFC Bank to offer white-label credit cards, where the latter will issue cards to customers of Equitas Small Finance Bank but the outstanding will remain on HDFC Bank books. Last year, the bank's peer AU Small Finance Bank launched its credit cards and has so far issued 225,000 cards.

Essar, Arcelor in \$2.4-bn pact for infra assets

THE SIGNING of the agreement on Friday brings closure to the fight between the two.

AM/NS said the deal covers a 25 million tonne per annum capacity jetty at the allweather, deep draft bulk port terminal at Hazira, captive and adjacent to the steel plant. It also includes a 16 million tonne all-weather, deep draft terminal at Visakhapatnam, Andhra Pradesh, along with an integrated conveyor connected to AM/NS India's 8 million tonne a year iron ore pellet plant in the port city.

Pune: Four unidentified men opened fire at a four wheeler on the Pune-Solapur highway and looted a cash of about Rs 3.6 crores in the early hours of



Man held for 'killing lover's husband'; saw web-series. crime films before plotting attack: Police

EXPRESS NEWS SERVICE PUNE, AUGUST 26

PUNE CITY police have arrested two persons, including the key accused, for allegedly killing Akshay Prakash Bhise (26) at Chandan Nagar on August 21 Police said the key accused, Santosh Satyavan Shinde (28) had an affair with Bhise's wife before their marriage and killed him in the hope of rekindling the relationship after eliminating her husband. The other person to be arrested is Sangram alias Babu Bamne (27), Shinde's alleged associate in the crime. Both Shinde and Bamne are residents of Solapur.

According to police. Bhise was a garbage van worker residing in Kharadi. Shinde was upset with Bhise's wife for calling of her relationship with him after marriage. Shinde saw Bhise as a hurdle to his hopes of rekindling the affair and, hence, he allegedly conspired with Bamne and al legedly shot him dead in the wee hours of August 21, police said.

An FIR in this case was filed at the Chandan Nagar police sta-Police said over the course of

investigation, they scanned CCTV footage of the crime scene and other locations. They eventually gathered clues

about the suspects and the sports bike they had used for committing the crime.

A team from the Crime Branch headed by inspector **Javant Rajurkar arrested Shinde** from Bidar in Karnataka or August 25. Police said Shinde was residing at Bhalki in Bidai district. His aide Bamne was working as a manager at a hote in Tembhurni in Solapur district.

According to a press release issued by the police on Thursday, the probe by assistant police inspector Vikas Jadhav revealed that before hatching the plan to kill Bhise. Shinde saw some web series, television serials and movies based on crime. He then procured a pistol illegally, the release stated, adding that he also stole a sports bike from Karnataka and got a helmet to

Police said Shinde kept watch on the movements of Bhise. Along with Bambe, he came to Pune on the bike. Shinde allegedly opened fire at Bhise before the two fled the spot.

shield his face.

The duo was handed over to the Chandan Nagar police station for further investigation. Police said they were probing where Shinde procured the pistol for killing Bhise.
