Lakhimpur Kheri case: Apex court to appoint judge by tomorrow to monitor probe

THE BUREAU New Delhi, November 15

AFTER THE Uttar Pradesh government agreed to the appointment of a former high court judge from outside the state, the Supreme Court on Monday said it will appoint a judge by Wednesday to monitor the ongoing probe into the deaths that took place in Lakhimpur Kheri.

Senior lawyer Harish Salve, appearing for the state government, told a Bench led by Chief Justice NV Ramana that he has no objection to any judge that the SC deems appropriate but the appointment should not be made by looking for a judge "who is from outside that Pradesh". "It needs one more day's time as it is considering former Punjab and Haryana High Court Judge Rakesh Kumar Jain to be the Bench.

Expressing concern about the level of offences in the investigation team, the CJ said that the concern is that they are bringing the task force that is problematic. There needs to be higher grade officers," Ramana said.

"Most officials in the investigation team are from Lakhimpur Kheri. You give us the names of 10 officers who are from the UP cadre but don't belong to the UP cadre but belong to the UP cadre," said the Bench led by the Chief Justice NV Ramana.
