ডেভিদ দেৰ পৰা অসমৰ এগৰাকী আই পি এছ বিষয়াৰ পত্নীয়ে নিয়মীয়াকৈ প্রটেকশ্যন মানি লয় বলি বাতৰি প্রকাশ পাইছিল। কিন্তু আই পি এছ বিষয়া গৰাকীৰ লগতে তেওঁৰ পত্নী এতিয়াও তদন্তৰ আওতালৈ নাহিল। সংবাদ মাধ্যমত প্ৰকাশ যে এই কল চেণ্টাৰবোৰ স্থাপনৰ আঁৰত অসমত যিগৰাকী মানুহ আছিল , তেওঁৰ নাম তছদিকৰ ৰহমান। এই তছদিকৰ ৰহমান অৱসৰপ্ৰাপ্ত আই এ এছ বিষয়া এগৰাকীৰ পত্ৰ। তছদিকুৰ ৰহমান ১৪ ছেপ্টেম্বৰত আৰক্ষীয়ে অভিযান চলোৱাৰ পূৰ্বেই পলায়ন কৰে। সংবাদ মাধ্যমৰ বাতৰি অনুসৰি, তছদিকুৰ ৰহমানে পলায়ন কৰা গাড়ীখনৰ নম্বৰ আছিল AS  $01~\mathrm{FA4501}$ । এই গাড়ীখন এতিয়াও আৰক্ষীৰ তদন্তৰ আওতালৈ অহা নাই। গাড়ীৰ গৰাকীকো আৰক্ষীয়ে তদন্তৰ আওতালৈ অনা নাই। কিয়নো এই গাড়ীখন এজন কুখ্যাত বিজেপি নেতাৰ ঘৰৰ গাড়ী। একেটা গোচৰত আৰক্ষীয়ে ধলাই থানাৰ পৰা জব্দ কৰিছিল UP 16 CW 4583 নম্বৰৰ গাড়ীখন।বাতৰি অনুসৰি এই গাড়ীখন চাইবাৰ অপৰাধী চক্ৰই কাছাৰৰ এগৰাকী শীৰ্ষ আৰক্ষী বিষয়াক উপহাৰ দিছিল। গাড়ীখনৰ গৰাকী হ'ল — 18 Construction Co. নামৰ এটা কোম্পানী। সেই কোম্পানীটোৰ মালিক হ'ল চৰ্দাৰ সুখদ্বীপ সিঙ গান্ধী ওৰফে মগন গান্ধী। এওঁ কুখ্যাত আৰ এছ গান্ধীৰ কনিষ্ঠ পুত্ৰ। উপহাৰ দিয়া মগন গান্ধী আৰু উপহাৰ লোৱা আৰক্ষী বিষয়া কোনো এতিয়ালৈকে তদন্তৰ আওতালৈ অহা নাই । সংবাদ মেলত অখিল গগৈৰ প্ৰশ্ন, ধলাই থানাৰ ভাৰপ্ৰাপ্ত আৰক্ষী বিষয়াজন আৰু কাছাৰৰ এছপিজন ইয়াৰ পাচতো এতিয়ালৈকে গ্ৰেপ্তাৰ হোৱা নাই কিয় ? দুৰ্নীতিৰ বিৰুদ্ধে বাঘৰ দৰে জঁপিয়াই পৰিম বুলি ঘোষণা কৰা মুখ্যমন্ত্ৰী এই ক্ষেত্ৰত মেকুৰী হৈছে কিয়? 18 Construction Co. নামৰ কোম্পানীটোৱে সমগ্ৰ অসমজুৰি কি কি ব্যৱসায় বাণিজ্য আছে তাৰ ওপৰত তদন্ত হ'বনে মুখ্যমন্ত্ৰী ডাঙৰীয়া বুলি অখিল গগৈয়ে প্ৰশ্ন উত্থাপন কৰে।

১৮ গুণ ডাঙৰ। গাজা ট্ৰিপৰ মাটিকালি ৩৬৫ বৰ্গকিলোমিটাৰ হোৱাৰ বিপৰীতে আফগানিস্তানৰ মাটিকালি ৬৫২,৮৬০ বৰ্গকিলোমিটাৰ, য'ৰ বৃহৎ অংশ পাহাৰীয়া আৰু গাজা হৈছে এক মক্ত আকাশৰ তলৰ সমতলভূমি। আফগানিস্তানত আমেৰিকাই ২০১০ চনত সৰ্বাধিক ৫৪১১ টা বোমা বৰ্ষণ কৰিছিল। আনহাতে ইজৰাইলে প্ৰথম ৬ দিনতে অৰ্থাৎ যোৱা শনিবাৰৰ পৰা বহস্পতিবাৰ পৰ্যন্ত গাজা অঞ্চলত বিস্ফোৰণ ঘটাইছে ৬০০০ টা শক্তিশালী বোমা, য'ৰ প্ৰথম তিনিদিনত বোমাৰ সৈতে সংলগ্ন কৰা হৈছিল মাৰাত্মকভাৱে জলন্ত অগ্নিপিণ্ড হোৱাইট ফছফৰাছ। হোৱাইট ফছফৰাছৰ বোমাত ৮০০ ডিগ্ৰী চেণ্টিগ্ৰেড উষ্ণতাৰ সৃষ্টি হয়, যি মানৱদেহ দুৰৰে, কথা, লোহাও গলাই দিব পাৰে। ইয়াৰ পৰিণতিত যোৱা শুকৰবাৰলৈকে গাজাত ৭২৪ টা শিশু আৰু ৪৫৮ গৰাকী মহিলাৰ মৃত্যু হৈছে। আজি দেওবাৰে যুদ্ধই নৱম দিনত ভৰি দিয়ালৈ নিহত শিশুৰ সংখ্যাই ১০০০ অতিক্ৰম কৰিছে। এই পৰিসংখ্যা আগবঢ়াইছে পেলেষ্টাইনৰ স্বাস্থ্য মন্ত্ৰণালয়ে। বিমানেৰে পেলোৱা বোমাৰ বিস্ফোৰণত আহত হৈছে ৩০০০ ৰো অধিক শিশু আৰু ২৫০০ ৰো অধিক মহিলা। ইজৰাইলৰ যদ্ধ বিমানে অসামৰিক অঞ্চলত বোমা বিস্ফোৰণ কৰাৰ ফলত আৰু বিস্ফোৰণত ধ্বংস হৈ পৰা আবাসস্থলৰ পৰা ততাতৈয়াকৈ ওলাই আহিব নোৱাৰাৰ ফলতে গাজাত বৃহৎ সংখ্যাত পেলেষ্টাইনী শিশু আৰু মহিলাৰ মৃত্যু হৈছে। ইজৰাইলৰ বোমা বর্ষণত বিগত ৯ দিনত গাজাত ৬৪২৮৩টা আবাসস্থল, ৯০খন শিক্ষান্ঠান, ১৯ খন চিকিৎসালয় আৰু ২০খন এম্বুলেন্স ধ্বংসস্তুপত পৰিণত হৈছে। বিস্ফোৰণৰ ফলত কেৱল উত্তৰ গাজাতে ১০,২৩০০০ লোক গৃহহীন হৈছে আৰু ২৭০৩৭৪ জনে ৰাষ্ট্ৰসংঘই স্থাপন কৰা আশ্ৰয় শিৱিৰত আশ্ৰয় লৈছে। ৰাষ্ট্ৰসংঘৰ তথ্য মতে পেলেষ্টাইনৰ ১০ লক্ষাধিক বাসিন্দা এসপ্তাহতে গৃহহীন হৈছে।

ইপিনে ইৰানে আকস্মিকভাৱে ইজৰাইল আক্ৰমণ কৰাৰ আশংকাত দেওবাৰে আমেৰিকাই ভূমধ্য সাগৰত থকা তেওঁলোকৰ দ্বিতীয়খন পাৰমাণৱিক অস্ত্ৰৰে শক্তিশালী এয়াৰ ফৰ্চ কেৰিয়াৰ যুদ্ধ জাহাজ ইউএছএছ আইজেনহাৱাৰক গাজাৰ কাষলৈ প্ৰেৰণ কৰিছে। ইতিপূৰ্বে আমেৰিকাই যোৱা দেওবাৰে তেওঁলোকৰ সৰ্ববৃহৎ ৰণতৰী, পাৰমাণৱিক অস্ত্ৰ পৰিবাহী ইউএছএছ ফৰ্ডক সম্পূৰ্ণ ষ্ট্ৰাইক গ্ৰুপসহ গাজাৰ কাৰলৈ পঠিয়াইছিল। ইউএছএছ ফৰ্ডৰ ষ্ট্ৰাইক গ্ৰুপত এয়াৰ ফৰ্চ কেৰিয়াৰ বিশ্বৰ সৰ্ববৃহৎ যুদ্ধ জাহাজ ফৰ্ডৰ উপৰি আছে ডেষ্ট্ৰয়াৰ, ফ্ৰিগেট, ছাবমেৰিনসহ মুঠ ১২ খন সৰু-বৰ যুদ্ধৰ জাহাজ। উল্লেখ্য, দেওবাৰে ইৰানে পুনৰ ইজৰাইলক সকিয়াই যুদ্ধৰ হুংকাৰ দিছে। ইৰানৰ বৈদেশিক মন্ত্ৰী হোছেইন আমিৰ আব্দুলাহিয়ানে দেওবাৰে ইজৰাইলক ক্ষান্ত হ'বলৈ পুনৰ আহ্বান জনাইছে আৰু অন্যথা আন এক সীমান্তত যুদ্ধৰ সন্মুখীন হ'ব লাগিব বুলি হুংকাৰ দিছে। ইজৰাইলৰ আশংকা, ইৰানে ছিৰিয়াৰ পৰা ইজৰাইলক আক্ৰমণ কৰিব পাৰে। ফলত ইজৰাইল পৰ্ব সীমান্ততো আক্ৰমণৰ সন্মুখীন হোৱাৰ আশংকাই দেখা দিছে। ইজৰাইলৰ দাবী, ইৰানে ইতিমধ্যে ছিৰিয়ালৈ অস্ত্ৰ আৰু সেনা প্ৰেৰণৰ প্ৰয়াস চলাইছে। সেই আশংকাত ইজৰাইলে শনিবাৰে ছিৰিয়াৰ এলেগ্গো বিমানবন্দৰ বোমা বিস্ফোৰনেৰে অকামিলা কৰি দিছে। এনে পৰিস্থিতিত আমেৰিকাই দুখনকৈ অতি শক্তিশালী এয়াৰ ফৰ্চ কেৰিয়াৰেৰে ইজৰাইলক ভমধ্যসাগৰৰ দিশৰ পৰা সৰক্ষা প্ৰদানৰ চেষ্টা চাইছে। মাৰ্কিন প্ৰতিৰক্ষা মন্ত্ৰী লয়ড অষ্টিনে কৈছে—' ইজৰাইলৰ সুৰক্ষাৰ প্ৰতি আমাৰ প্ৰতিশ্ৰুতি লৌহবন্ধনৰ দৰে। সেইবাবেই বাশ্বিংটনে গাজাৰ কাষলৈ দুখন পৰমাণু অস্ত্ৰবাহী যুদ্ধ জাহাজ প্ৰেৰণ কৰিছে, যাতে কোনেও ইজৰাইলক আক্ৰমণ কৰিবলৈ সাহ কৰিব নোৱাৰে।' নাম উচ্চাৰণ নকৰিলেও ইৰানৰ ইজৰাইল আক্ৰমণৰ আশংকাতে যে জো বাইডেন চৰকাৰে দুখনকৈ বৃহৎ যুদ্ধ জাহাজেৰে ইজৰাইলক ভূমধ্য সাগৰৰ পৰা পহৰা দিছে, সেয়া লয়ড অষ্টিনৰ বক্তব্যত প্ৰকাশ পাইছে।

ইপিনে ইমানদিনে এই যুদ্ধ সম্পৰ্কত কোনো মন্তব্য নকৰা চীনে দেওবাৰে কৈছে, ইজৰাইলৰ আত্মৰক্ষাৰ প্ৰচেষ্টাই এতিয়া সীমা অতিক্ৰম কৰিছে। এতিয়া ইজৰাইলে পৰিস্থিতি আৰু প্ৰতিক্ৰিয়া বুজি নিজকে ক্ষান্ত কৰা প্ৰয়োজন। যুদ্ধৰ নৱম দিনত চীনৰ বৈদেশিক মন্ত্ৰী ৱাং ইয়ে কৰা এই মন্তব্যই আগ্ৰাসী ইজৰাইলক স্থলভাগেৰে সামগ্ৰিক আক্ৰমণৰ ঠিক পূৰ্বে স্তম্ভিত কৰাৰ লগতে আমেৰিকাকো চিন্তিত কৰি তুলিছে।

সাংসদৰ দৰে 'ধনৰ বিনিময়ত প্ৰশ্ন কাণ্ড'ৰ পুনৰাবৃত্তি কৰাৰ গুৰুতৰ আৰু চাঞ্চলকৰ অভিযোগ উত্থাপিত হৈছে। মমতা বেনাৰ্জীৰ দলৰ সাংসদ মহুৱা মৈত্ৰই উপঢৌকন আৰু ধনৰ বিনিময়ত সংসদত প্ৰশ্ন উত্থাপন কৰাৰ নিৰ্দিষ্ট অভিযোগ উত্থাপন কৰি বিজেপিৰ ঝাৰখণ্ডৰ সাংসদ নিশিকান্ত ডুবেই লোকসভাৰ অধ্যক্ষ ওম বিৰলালৈ এখন পত্ৰ প্ৰেৰণ কৰিছে। সেই পত্ৰত নিশিকান্ত ভূবেই তৃণমূল কংগ্ৰেছৰ কৃষ্ণনগৰৰ সাংসদ মহুৱা মৈত্ৰৰ সাংসদ পদ কাঢ়ি নিয়াৰ (নিলম্বিত) আবেদন জনাইছে। একে সময়তে বিজেপিৰ সমৰ্থক এজন অধিবক্তা অনন্ত দেহদৰিয়ে মহুৱা মৈত্ৰ বিৰুদ্ধে একেই অভিযোগ উত্থাপন কৰি চি বি আইৰ সঞ্চালক প্ৰবীণ সুদলৈ পত্ৰ প্ৰেৰণ কৰি তদন্তৰ আহ্বান জনাইছে। দুয়োৰে অভিযোগ, ব্যৱসায়ী দৰ্শন হীৰানন্দানিৰ পৰা ধন আৰু উপহাৰ লৈ সাংসদ মহুৱা মৈত্ৰই লোকসভাত বিজেপিৰ ঘনিষ্ঠ উদ্যোগপতি গৌতম আদানিৰ বিৰুদ্ধে ৫০টাকৈ প্ৰশ্ন উত্থাপন কৰিছিল। অভিযোগ অনুসৰি মহুৱা মৈত্ৰই আদানিৰ বিৰুদ্ধে প্ৰদান কৰা বক্তব্যত কেন্দ্ৰীয় গৃহমন্ত্ৰী অমিত শ্বাহকো জড়িত কৰিছিল। ঝাৰখণ্ডৰ গোড্ডাৰ বিজেপি সাংসদ নিশিকান্ত ডুবেই ওম বিৰলালৈ প্ৰেৰণ কৰা পত্ৰত মহুৱা মৈত্ৰৰ বিৰুদ্ধে স্বাধিকাৰ ভংগ আৰু সংসদ অৱমাননাৰ অভিযোগ উত্থাপন কৰিছে। তদুপৰি ডুবেই মহুৱাৰ এই কাৰ্যক ফৌজদাৰী অপৰাধ বুলি দাবী কৰিছে। ডুবেৰ দাবী, মুম্বাইৰ প্ৰখ্যাত হীৰানন্দানি ৰিয়েল ইষ্টেটৰ চিইঅ' ৪২ বছৰীয়া সুদৰ্শন উদ্যোগপতি দৰ্শন হীৰানন্দানিৰ সৈতে তৃণমূল সাংসদ মহুৱা মৈত্ৰৰ ঘনিষ্ঠ সম্পৰ্ক। বিদেশলৈকো ৰিয়েল ইষ্টেট ব্যৱসায় সম্প্ৰসাৰণ কৰা আৰু অন্যান্য একাধিক ব্যৱসায়ৰ সৈতে জড়িত দৰ্শন হীৰানন্দানিৰ নিউয়ৰ্কৰ ৰক'ষ্টাৰ ইনষ্টিটিউট অব টেকন'ল'জিৰ এম বি এ। আনহাতে আমেৰিকাৰ মাছাছুছেটছৰ মাউণ্ট হলিঅ'ক কলেজৰ এম বি এ আৰু জে পি মৰগান বেংকৰ নিউয়ৰ্ক তথা লণ্ডনত বেংকাৰ হিচাপে এসময়ত কৰ্মৰত মহুৱা মৈত্ৰৰ দৰ্শন হীৰানন্দানিৰ সৈতে সম্পৰ্ক পুৰণি আৰু এতিয়া ঘনিষ্ঠ বুলি প্ৰকাশ। মহুৱা মৈত্ৰই দৰ্শন হীৰানন্দানিৰ ব্যৱসায়ক সুৰক্ষা দিয়াৰ বাবে সংসদত আদানি-বিৰোধী প্ৰশ্ন কৰা বুলি অভিযোগ কৰিছে সাংসদ ভূবে আৰু অধিবক্তা দেহদৰিয়ে। অভিযোগ অনুসৰি মহুৱা মৈত্ৰই লোকসভাত কৰা ৬১ টা প্ৰশ্নৰ ৫০ টাই দৰ্শন হীৰানন্দানিৰ ব্যৱসায়ৰ সৈতে সম্পৰ্ক থকা আৰু গৌতম আদানিক শলঠেকত পেলোৱাৰ উদ্দেশ্যে কৰা। এই ৫০ টা প্ৰশ্নৰ বিনিময়ত মহুৱা মৈত্ৰই দৰ্শন হীৰানন্দানি পৰা ধন আৰু উপহাৰ গ্ৰহণ কৰিছে বুলি অভিযোগ। সাংসদ ডুবেৰ অভিযোগ, মহুৱাৰ প্ৰশ্নৰ পাছতে উদ্দেশ্যপ্রণোদিতভাৱে কেইবাজনো সাংসদ সংসদত বাৰম্বাৰ সৰব হৈছিল, য'ৰ অন্যতম তৃণমূলৰ প্ৰবীণ সাংসদ সৌগত ৰায়।

বিজেপিৰ সাংসদ নিশিকান্ত ডুবেই কিদৰে মহুৱা মৈত্ৰক নিলম্বিত কৰিব পাৰি, তাৰ পৰামৰ্শ দি বিজেপিৰে পুৰণি ঘাঁ খুছৰি দিছে। ডুবেই কৈছে, ২০০৬ চনত চতুৰ্দশ লোকসভাত এনে ঘটনা সংঘটিত হওঁতে তৎকালীন অধ্যক্ষই এখন তদন্ত কমিটী গঠন কৰিছিল আৰু তাৰ ২৩ দিনৰ ভিতৰত ১০জন লোকসভাৰ সাংসদক বৰ্খাস্ত কৰা হৈছিল। ডুবেৰ মতে মহুৱাকো তেনেদৰেই অপসাৰণ কৰিব লাগে। বিজেপিৰ সাংসদজনে যি ঘটনাৰ কথা উল্লেখ কৰিছে, সেয়া বিজেপিৰ বাবে সংসদত সৰ্বকালৰ কলংকিত অধ্যায়। যি ১০ জন সাংসদক লোকসভাৰ পৰা ধনৰ বিনিময়ত প্ৰশ্ন কৰাৰ বাবে বৰ্খাস্ত কৰা হৈছিল, তাৰ ৬ জনেই আছিল বিজেপিৰ সাংসদ। তেওঁলোক আছিল ৱাই জি মহাজন, চত্ৰপাল সিং লোধা, আন্না চাহেব এম কে পাটিল, চন্দ্ৰপ্ৰতাপ সিং, নৰেন্দ্ৰ কুমাৰ কুশৱাহা আৰু সুৰেশ চাণ্ডেল। এই ৬ বিজেপি সাংসদে সদনত প্ৰশ্ন কৰাৰ বিনিময়ত ধন লোৱাৰ লজ্জাজনক ঘটনা উন্মোচিত কৰিছিল ক'ব্ৰাপোষ্ট নামৰ এটা সংবাদ প্ৰতিষ্ঠানে। বৰ্খাস্ত কৰাৰ পাছত তেতিয়াৰ বিজেপিৰ লোকসভাৰ বিৰোধী দলপতি লালকৃষ্ণ আদৱানীয়ে কৈছিল—'সাংসদ কেইজনে টকা লৈ যিমান কেলেংকাৰি কৰিছে, তাতকৈ মুৰ্খামি কৰিছে বেছি। তেওঁলোকৰ অপৰাধতকৈ শাস্তি অধিক গুৰুতৰ হ'ল।'

স্পষ্ট কৰি দিছে মুখ্যমন্ত্ৰী হিমন্ত বিশ্ব শৰ্মাই। গুৱাহাটীৰ ভিতৰত কম দূৰত্বত মেট্ৰ' চলাচল আৰু মেট্ৰ' ৰে'লৰ ষ্টেচন নিৰ্মাণতো জটিলতা থকা বুলি সদৰি কৰিছে মুখ্যমন্ত্ৰীয়ে। অৱশ্যে গুৱাহাটী সংযোগী ৰিং ৰোড নিৰ্মাণ সম্পূৰ্ণ হ'লেই ৰিং ৰোডৰ ওপৰত মেট্ৰ'ৰ পৰিকল্পনা থকাৰ কথাও ব্যক্ত কৰিছে মুখ্যমন্ত্ৰীয়ে। শনিবাৰে মাজনিশা জু-ৰোডৰ নৱনিৰ্মিত শ্ৰদ্ধাঞ্জলি উৰণ সেতুৰ নিৰ্মাণ কাৰ্য পৰিদৰ্শন কৰি মেট্ৰ' ৰে'লৰ প্ৰসংগত এই তাৎপৰ্যপূৰ্ণ মন্তব্য কৰে মুখ্যমন্ত্ৰী হিমন্ত বিশ্ব শৰ্মাই। সাংবাদিকৰ আগত মুখ্যমন্ত্ৰী শৰ্মাই কয়— চানমাৰিৰ পৰা গুৱাহাটী ক্লাবলৈ দূৰত্ব হৈছে আঢ়ৈ কিলোমিটাৰ। আঢ়ৈ কিলোমিটাৰ দূৰত্বত মেট্ৰ' সম্ভৱেই নহয়। মেট্ৰ'হ'লেও যাত্ৰীয়ে গুৱাহাটী ক্লাবত নামি চানমাৰিলৈ খোজকাঢ়ি আহিব লাগিব। গুৱাহাটী ক্লাব আৰু চানমাৰিৰ মাজত ষ্টেচন হ'ব নোৱাৰে। মেট্ৰ'ৰ এটা ষ্টেচনৰ ব্যৱধান তিনি কিলোমিটাৰ থাকে। তিনি কিলোমিটাৰত আমাৰ গুৱাহাটীখন শেষেই হৈ যায়। যদি আপুনি মেট্ৰ' ৰে'লৰ চলাচল হয়, তেনেহ'লে উলুবাৰীত এটা ষ্টেচন উলুবাৰীত হ'ব, এটা ষ্টেচন ভঙাগড়ত হ'ব আৰু এটা ষ্টেচন গণেশগুৰিত হ'ব। তেনে দীৰ্ঘ দূৰত্বৰ ষ্টেচন আমাৰ মানুহক নালাগে। সেয়েহে মেট্ৰ' আমাৰ মূল গুৱাহাটীত সম্ভৱ নহয়। যেতিয়া গুৱাহাচীত ৰিং ৰোড হ'ব তেতিয়া ৰিং ৰোডৰ চাৰিওফালে মেট্ৰ' হ'ব। ৰিং ৰোডৰ পৰা ভিতৰলৈ সোমাই অহাৰ বাবেও মেট্ৰ' হ'ব। সেয়ে মেট্ৰ' আমাৰ ভৱিষ্যদৰ্শন। কিন্তু যাক আমি আচলতে গুৱাহাটী বুলি কওঁ— গুৱাহাটী ক্লাব, চানমাৰি, জি এছ ৰোড সেইখিনিত মেট্ৰ'ৰ কোনো সুবিধাই নাই। মেট্ৰ' ৰে'লৰ এটা ষ্টেচন নিৰ্মাণৰ বাবে ভয়ংকৰ ভূমি অধিগ্ৰহণ কৰিব লাগিব। তেতিয়া ইয়াত মানুহৰ ঘৰেই নাথাকিব। খানাপাৰাৰ পৰা এয়াৰপ'ৰ্টলৈ ৰোপ-ৱে' নিৰ্মাণৰ বিচাৰ-বিবেচনা চলি আছে। বৰ্তমান আমাৰ ৰিং ৰোড নিৰ্মাণ কৰাটোৱে প্ৰাথমিক লক্ষ্য আছে। নাৰেংগী, কুৰুৱা হৈ ৰাষ্ট্ৰীয় ঘাইপথ আকৌ আমিনগাঁও, এইমছ এইধৰণৰ ৰিং ৰোড নিৰ্মাণ কৰাটো বৰ্তমান আমাৰ টাৰ্গেট। ৰিং ৰোডৰ ওপৰতেই মেট্ৰ' হ'ব। মেট্ৰ' গুৱাহাটীৰ ভিতৰত অসম্ভৱ। কেতিয়াবা যদি সৰু মেট্ৰ' আহে সেইটো বেলেগ কথা।'
