Sub: Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Allotment of Rights Equity Shares, kept in abeyance

With reference to our disclosure dated 2nd February 2024, wherein the Company has allotted 2,20,67,231 Rights Equity Shares against issuance of 2,20,73,935 Rights Equity Shares to eligible equity shareholders. Further, 6,704 Rights Equity Shares were kept in abeyance pending regulatory/other clearances.

This is to inform you that Rights Issue Committee – 2023 of the Board of Directors of the Company vide its circular resolution passed on 7th March 2024 has approved the allotment of 3,679 Rights Equity Shares of ₹ 1,812 per equity share (including a premium of ₹ 1,810 per equity share) of which ₹ 453 per equity share (i.e. ₹ 0.50 has been paid-up as share application money and ₹ 452.50 as a premium per equity share) to eligible applicants in compliance with order passed by the Hon'ble Special Court constituted under the Special Court (Trial of Offences Relating to Transactions in Securities) Act, 1992.
