Consequent to Share Purchase Agreement entered on 31st July, 2023 between the acquirers and selling/promoter shareholders, Sarvottam Finvest Limited (“Company”) had filed the application with Reserve Bank of India, Kolkata seeking prior approval for proposed change in (a) Shareholding exceeding 26% of the paid-up equity capital; and (b) change in management which results in change in more than 30% of Directors of Sarvottam Finvest Limited.
