# Shinde unveils Chhatrapati Shivaji Maharaj's statue in Kashmir

Mumbai, Nov 7 (UNI) : Maharashtra Chief Minister Eknath Shinde on Tuesday unveiled an equestrian statue of Chhatrapati Shivaji Maharaj installed near the Indo-Pak Line of Control (LoC) at Kupwara in Kashmir.

Speaking on occasion, he said, "We have installed a statue of Chhatrapati Shivaji Maharaj at Kupwara through Puneekar Sanstha, 41 National Rifle Maratha Battalion. It is of great importance that the statue of Chhatrapati Shivaji Maharaj was erected at Kupwara in 350th year of

Chhatrapati Shivaji Maharaj's Coronation." He further said that this statue of Chhatrapati Shivaji Maharaj will inspire and energise the country.

Also, this will boost morale among people of Kupwara and will become an inspiration for tourists visiting Jammu and Kashmir, he said and assured that the state government will provide necessary cooperation for this.

Shinde further said that the equestrian statue of Chhatrapati Shivaji Maharaj with a sword in

his hand is looking towards Pakistan.

"Since Maharaj is here, the enemy will not dare to set foot here. Even terrorists will not dare to enter Kashmir after seeing this statue," he added.

On this occasion, Deputy Governor of Jammu & Kashmir Manoj Sinha, Maharashtra Cultural Affairs Minister Sudhir Mangunthwar, Maharashtra State Planning Board executive chairman Rajesh Kshirsagar, We Puneekar Sanstha trustees Abhaysingh Shirole, Hemant Jadhav and other dignitaries were present.

# Bombay HC rejects Naresh Goyal's plea challenging his 'illegal' arrest

Mumbai, Nov 7 (UNI) : Bombay High Court on Tuesday rejected a petition filed by Jet Airways founder Naresh Goyal challenging his 'illegal' arrest by the Enforcement Directorate (ED) in a money laundering case linked to default of loan sanctioned by Canara Bank. A Division bench comprising Justice Ravati Mohite Dere and Justice Gauri V. Godse in its order said that the "petition cannot be entertained and is dismissed", while allowing Goyal liberty to avail other statutory remedies.

Goyal, 74, had contended that

his arrest was 'illegal' and sought the setting aside of the Special Court order remanding him to ED custody and later in judicial custody. The Jet Airways Founder, who had sought bail on medical grounds in September, claimed that the arrest violated his fundamental right to personal liberty as guaranteed by Article 21 of the Constitution, and sought directions to release him from the 'abjectly

unlawful and arbitrary custody and incarceration".

Recently he and other accused in the case were charged sheeted by the ED.

Goyal was arrested by the ED on September 1 under the Prevention of Money Laundering Act (PMLA).

He is currently in judicial custody and lodged at the Arthur Road jail here. The money laundering case stems from the first information report

(FIR) of the Central Bureau of Investigation (CBI) against Goyal, his wife Anita and some former company executives of the now-grounded private airline in connection with the alleged fraud case.

The FIR was registered on the bank's complaint, which alleged that it sanctioned credit limits and loans to Jet Airways (India) Limited to the tune of Rs 48.86 crore, of which Rs 38.62 crore was outstanding.

## Mobile internet suspended in parts of J&K's Pulwama

Srinagar, Nov 7 (UNI) : Authorities in Jammu and Kashmir have suspended mobile internet in parts of Pulwama district amid apprehensions that the services may be "misused" by anti-national elements. The mobile internet data has been suspended in the Wampora and Hunpora area of Pulwama district for 72 hours with effect from 7pm on November 5 to 8th on the direction of Additional Director General of Police (ADGP), Kashmir, Vijay Kumar. The steps were taken as there was possibility of mobile data services may be misused by anti-national elements, miscreants, which may cause deterioration in public order," they said.
