- Recommended the Scheme of Arrangement of Reduction of Share Capital of the Company consequent upon receipt of "Observation Letter/No-objection Letter" from BSE Limited; for approval of the Members of the Company at the 33rd Annual General Meeting (AGM) of the Company.
- 3. The 33rd Annual General Meeting (AGM) of the Members of IMEC Services Limited will be held on Thursday, September 30, 2021 through Video Conferencing / Other Audio Visual Means in accordance with the relevant circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India; and
