For the Design-Build of the Works, the amount is **INR 146,80,97,283/-** (INR One Hundred Forty Six Crore, Eighty Lac, Ninety Seven Thousand, Two Hundred and Eighty Three only).

For the Operation and Maintenance Services, the amount is **INR 18,42,91,680/-** (INR Eighteen Crore, Forty Two Lac, Ninety One Thousand, Six Hundred and Eighty only).

For the Assets Replacement Fund, the amount is **INR 20,00,000/-** (INR Twenty Lac only).


