 - (vii) that in order to ensure active participation of Shareholders, Shareholders were requested to send their queries / clarifications through email until 2 days before the AGM and there were no queries received;
 - (viii) that Register of Directors and Key Managerial Personnel and their Shareholding and Register of Contracts or Arrangements in which Directors are interested are available for inspection by Members in the Website of the Company; and
 - (ix) the Company is in due compliance of applicable provisions of the Companies Act, 2013 and SEBI Regulations, in respect of 26th AGM.

- 11. Statutory Auditor affirmed that there are no qualifications, adverse remarks or comments or observations on the financial statements of the Company and thus, Independent Auditor's Report was taken as read.
