In terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that the operations at the company's plant located in Vill : Dhudhua, Tehsil : Jandaha, Dist:Vaishali, Bihar have been temporarily disrupted owing to flooding and water logging at the factory premises caused by heavy rains since 15<sup>th</sup> August 2021.
