Sub: Forfeiture of Upfront Subscription Amount paid on subscription of Convertible Warrants issued by the Company

Dear Sir/Madam,

This has reference to the intimation submitted to your good office on 2nd February, 2018 bearing reference no. Orient/Stock Exch/Letter/86, announcing the allotment of 62,96,800 Convertible Warrants to Mr. Manan Shah, Promoter & Promoter Group Member ("Warrant Holder") at a price of Rs. 51.31. In this connection, the said Convertible Warrants were convertible into Equity Shares in to one or more tranches within a period of 18 months from the date of allotment i.e. on or before 1st August, 2019.

Further, as required under the SEBI (LODR) Regulation, 2015 ("SEBI Regulations"), the Warrant Holder had deposited with the Company upfront 25% of total issue size i.e. Rs. 807,72,202 and the balance 75% of issue size i.e. Rs. 2423,16,606 was payable as an when the option to convert is exercised by the Warrant Holder.

The Company received a letter dated 10th June, 2019, from the Warrant Holder that he was not keen on opting to convert the aforesaid Warrants and thus conveyed his inability to further exercise his right of conversion into equivalent number of Equity Shares.

As a consequence thereof, the Board of Directors of the Company at its Meeting held on 12th August, 2019, took note of the forfeiture of Upfront Warrant subscription amount of Rs. 807,72,202 paid by the Warrant Holder in terms of aforesaid SEBI Regulations.
