

- 4 The Government of India, on September 20, 2019, vide the Taxation Laws (Amendment) Act 2019, inserted a new Section 115BAA in the Income Tax Act, 1961, which provides an option to the Company to pay income taxes at reduced tax rates as per the provisions/conditions defined in the said section. The Company had evaluated and expects to exercise the option of lower tax rate of 25.17% (inclusive of surcharge and cess) under Section 115BAA of the Income Tax Act, 1961 subsequently. Accordingly, the Company had estimated the reversal of deferred tax asset/liabilities, until the date of exercise of the option and subsequent to exercise of the option. The effect of this change had been recognized in tax expense for the year ended March 31, 2020 on an effective tax basis. This had resulted in an increase in deferred tax expense of ₹ 32.76 million for the quarter ended March 31, 2020 and ₹ 100.50 million for the year ended March 31, 2020 on account of remeasurement of deferred tax asset.

बुके, पिझ्झा, अंडी, भाज्या, मास्क, ओरिगामी कलाकृती, आपल्या नावाचा शिक्का बनवून देणारी व्हेंडिंग मशिन्स आहेत. सगळ्यात गम्मत म्हणजे इथे पाळीव कुत्री आणि मांजरे मिळणारीही व्हेंडिंग मशिन्स आहेत.


