नागपूर : जंगलालगतच्या गावातील गावकऱ्यांचा जंगलावरील भार कमी करण्यासाठी राज्याचे वनखाते कितीही योजना आखत असले, तरीही अंमलबजावणीतील त्रुटीमुळे हा भार वाढतच चालला आहे. जंगलातून जळाऊ लाकडाचा सर्वाधिक उपयोग करण्याच्यामध्ये महाराष्ट्र अग्रक्रमावर आहे. सुमारे ९५ लाख ३९ हजार टन जळाऊ लाकडाचा वापर राज्यात दरवर्षी केला जातो. त्यापाठोपाठ ओडिशा, राजस्थान आणि मध्य प्रदेश ही राज्ये अनुक्रमे दुसऱ्या, तिसऱ्या आणि चौथ्या क्रमांकावर आहेत.

केंद्रीय वने, पर्यावरण आणि हवामान बदल विभागांतर्गत भारतीय वनसर्वेक्षण विभागाच्यावतीने दर दोन वर्षांत जंगलक्षेत्र किती वाढले, किती कमी झाले याचे सर्वेक्षण करून अहवाल तयार करण्यात येतो. २०१९च्या अहवालात हे सर्वेक्षण करताना सोबतच जंगलालगतच्या गावातील गावकऱ्यांचे जंगलावर वाढणारे अवलंबित्व यांचेही प्रमाण शोधण्यात आले. हे सर्वेक्षण करताना जंगलाच्या आतील, जंगलापासून एक किलोमीटर, दोन किलोमीटर आणि तीन किलोमीटरवरील अशा चार

वनउपजांचा वापर असा...

राज्यात दरवर्षी गावकरी जंगलातून सुमारे ९५ लाख ३९ हजार टन जळाऊ लाकूड, १५ कोटी ७९ लाख ३६ हजार टन चारा, एक लाख २८ हजार टन बांबू आणि आठ लाख ७२ हजार ९३८ घनमीटर लहान लहान इमारती लाकूड वापरतात, असे या अहवालातून स्पष्ट झाले आहे.

भागांत विभाजन करण्यात आले.

राज्यात जंगलाच्या आसपास म्हणजेच तीन किलोमीटरच्या परिसरात राहणाऱ्यांची संख्या सुमारे चार कोटी २३ लाख १९ हजार ६४८ इतकी आहे. यातील ६२ गावे सर्वेक्षणासाठी निवडण्यात आली. जंगलाच्या आतील पाच गावे, एक आणि दोन किलोमीटर परिसरातील प्रत्येकी २२ गावे आणि तीन किलोमीटरच्या आतील १८ गावांचा समावेश आहे. या सर्वेक्षण अहवालातून समोर आलेले तथ्य धक्कादायक होते. गावाच्या आसपासच्या जंगलावरील भार वाढतच चालला असून हे प्रमाण खूप जास्त असल्याचे या अहवालात नोंदवण्यात आले आहे. मानव-वन्यजीव संघर्ष टाळण्यासाठी आणि जंगलक्षेत्र वाढवण्यासाठी २०१२ मध्ये ७५ टक्के शासकीय अनुदान व २५ टक्के लाभाभ्यांचे योजनाने यानून जंगलालगतच्या गावकऱ्यांसाठी गॅस



सिलेंडर योजना सुरू करण्यात आली.

मात्र सिलेंडर संपल्यानंतर ते आणण्यासाठी शहराकडे धाव घ्यावी लागत असल्याने गावकरी पुन्हा सरपणाकडे वळले. त्यानंतर २०१७ मध्ये डॉ. श्यामाप्रसाद मुखर्जी जनवनविकास योजनेची व्यापी वाढवत गॅस जोडणीसोबत दोन सिलेंडर, प्रथम वर्षाच्या उर्वरित कालावधीसाठी सहा आणि दुसऱ्या वर्षात सवलतीच्या दरात सहा सिलेंडर असा योजनाविस्तार करण्यात आला. मात्र येथेही सिलेंडर संपल्यानंतर काय, हा प्रश्न उठतो. योजना चांगली असली तरीही गावकऱ्यांपर्यंत सिलेंडर पोहोचवण्याची व्यवस्था नसल्याने ती यशस्वी होऊ शकली नाही. त्यामुळेच राज्यात अजूनही गावकरी जंगलातून जळाऊ लाकडे आणत आहेत. परिणामी जंगलावरील त्यांचे अवलंबित्व कमी होण्याऐवजी वाढत असल्याचे दिसून येत आहे.
