TVS Motor enters Europe's e-bike mkt with EGO's acquisition

TVS MOTOR COMPANY, the flagship of the \$8.5-billion TVS Group, on Thursday announced the acquisition of Switzerlandheadquartered e-bike maker EGO Movement for a consideration of 16.6 million Swiss franc (CHF).

After the acquisition, TVS Motor plans to grow the e-bike business across Europe and later expand to the US and Indian markets. The company expects to generate revenue of \$100-150 million from the e-bike business in another five years.

TVS Motor has bought an 80% stake in EGO Movement in an all-cash deal through its subsidiary TVS Motor (Singapore). This is its second major acquisition in Europe after Norton Motorcycles.Led by co-founders Daniel Meyer and Marie So, EGO

Movement is a Swiss technology company providing mobility solutions through a portfolio of e-bikes, e-cargo bikes, and escooters. The company combines designs with software and hardware and has an omnichannel network across Switzerland,

Liechtenstein & Germany with plans to expand across Europe. Sudarshan Venu, joint MD, TVS Motor, said that the e-bike space has been dramatically growing, particularly in Europe
