Ballot is 'referendum' on how Parliament should run, says Margaret Alva

's candidate for the President's post, Margaret Alva has written a letter to all MPs across the country and said this V-P election should be seen as a referendum on how Parliament should run.

Written to Members of Parliament across parties, she says why I think the Vice President's election on Aug 6th is not just a formality, but must be seen as a referendum on how Parliament is being run. We must have the power to bring about change. I've urged them to use that power, she tweeted.

Alva said the President's election, in which all members of Parliament will vote, is not just a formality. "It must be

The reason the election to the Vice President's post is not subject to a party whip and is by secret ballot, is to give members an opportunity to vote without fear for a candidate they believe will do justice to this critical position. A candidate who will be impartial, fearless, and run the upper house in a manner befitting its stature. I believe I am that candidate, and I'm writing to ask you for your support
