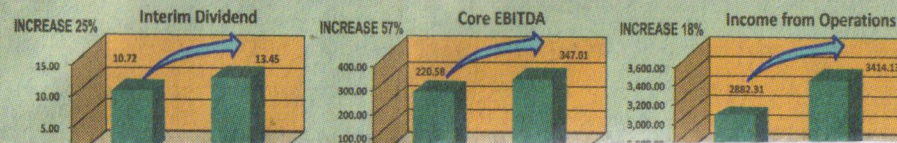

निंदात्मक दंड को चुनौती देने वाली याचिका खारिज

प्रयागराज, 11 फरवरी (भाषा)।

इलाहाबाद हाई कोर्ट ने न्यायिक अधिकारी लल्लू सिंह द्वारा दायर रिट याचिका खारिज कर दी है। लल्लू सिंह द्वारा एक न्यायिक आदेश पारित करते समय लापरवाही बरतने के लिए हाई कोर्ट ने उनके खिलाफ निंदात्मक दंड लगाया था।

न्यायमूर्ति सुधीर अग्रवाल और न्यायमूर्ति राजीव मिश्रा के पीठ ने निंदात्मक दंड के खिलाफ दायर याचिका खारिज करते हुए कहा, 'वास्तव में रिकार्ड से पता चलता है कि समन कभी जारी नहीं किए गए इसलिए ये कभी आरोपी को नहीं मिले और इस तथ्य का सत्यापन किए बगैर आरोपी के खिलाफ गैर जमानती वारंट जारी करना, याचिकाकर्ता की ओर से एक गंभीर लापरवाही है। इस वारंट के जारी होने के परिणामस्वरूप रीडर एवं

विभागाध्यक्ष के पद पर आसीन व्यक्ति को जेल भेज दिया गया।'

आपराधिक मुकदमे के इस मामले में याचिकाकर्ता/तत्कालीन मजिस्ट्रेट ने 30 नवंबर, 1999 को मामले की सुनवाई की तारीख 21 दिसंबर, 1999 तय की और आरोपी को तलब किया। जब आरोपी तारीख पर नहीं आया तो मजिस्ट्रेट ने 15 फरवरी, 2000 की अगली तारीख तय की और इस तारीख पर भी आरोपी के हाजिर नहीं होने पर उसके खिलाफ गैर जमानती वारंट जारी कर दिया गया।

वास्तव में इस मामले में आरोपी को समन जारी ही नहीं किए गए, इसलिए वह तारीख पर अदालत में हाजिर नहीं हुआ। जब यह तथ्य देते हुए कि समन कभी जारी नहीं किए गए, आवेदन दाखिल किया गया तो इस आवेदन को खारिज कर दिया गया और आरोपी को जेल भेज दिया गया।

सड़क हादसे में तीन महिलाओं समेत नौ की मौत

जयपुर, 11 फरवरी (भाषा)।

राजस्थान के भीलवाड़ा जिले में सोमवार देर रात एक सड़क हादसे में नौ लोगों की मौत हो गई जिनमें छह पुरुष व तीन महिलाएं शामिल हैं। पुलिस के अनुसार यह हादसा कोटा राजमार्ग पर उस समय हुआ जब एक जीप और रोडवेज की बस में टक्कर हुई। जीप में सवार लोग एक ही परिवार के थे और मध्य प्रदेश के मंदसौर जिले में संधारा गांव से शादी कार्यक्रम से लौट रहे थे। भीलवाड़ा के पुलिस अधीक्षक हरेंद्र कुमार ने बताया, 'छह पुरुष व तीन महिलाओं सहित नौ लोगों की मौत हुई है। छह लोगों को भीलवाड़ा के अस्पताल में भर्ती करवाया गया है जिनमें तीन की हालत गंभीर है।' मृतकों की शिनाख्त पार्थ शर्मा (18), प्रदीप शर्मा (32), त्रिलोक शर्मा (52), कौशल्या शर्मा (48), मनीष शर्मा (21), राजेंद्र शर्मा (50), दीपक बैरागी (21) और जीप चालक नइम डाबला के रूप में हुई है।
