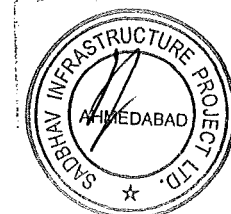
With reference to above subject and pursuant to the Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, read together with the circulars and notifications issued thereunder ("Listing Regulations"), we would like to inform you that Rohtak-Panipat Tollway Private Limited (a wholly owned subsidiary of the Company or SPV or RPTPL) vide its letter dated 27th July, 2021 has submitted Notice of Termination of project as per Concession Agreement dated 9th March, 2010 with National Highways Authority of India (NHAI) due to forceful suspension of toll collection/ User Fee because of the farmers' agitation / protest with effect from December 25, 2020.

Also note that the event of forceful suspension of toll collection/ User Fee because of the farmers' agitation / protest with effect from December 25, 2020, amounted to a Force Majeure Event as per the provisions of the Concession Agreement with NHAI.



You are requested to take the same on record.

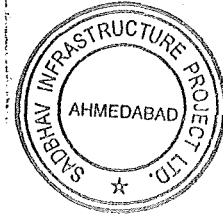

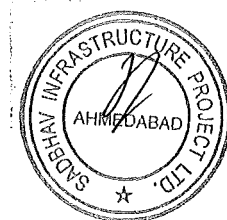
