Congress releases second list of 88 candidates in MP

The Congress has announced its second list of 85 candidates for the Madhya Pradesh assembly polls. With this list issued late Thursday night, the party declared all but one candidates for elections to the 230-member assembly scheduled for November 17. The Congress has not yet declared its candidate from Amla seat in Betul district from where a woman deputy collector Nisha Bangre is seeking a ticket but the ruling BJP government has not yet accepted her resignation from the services and the matter at present is pending in the court, the party sources said. Earlier the party had declared candidates for 144 seats but changed candidature in three

seats while issuing the second list. Therefore, the total number of candidates announced in the first list stands at 141, a Congress leader said. After intense tussle in the party that led to the "tearing of clothes" controversy, the Congress has replaced tickets of Datia, Goteagaon and Pichhore seats. A video of Madhya Pradesh Congress president Kamal Nath where he is asking party men to "tear clothes" of his colleague Digvijaya Singh over denial of ticket to a leader from Shivpuri fuelled talks of a rift in the party over selection of nominees even as the two former chief ministers sought to make light of the episode and on Tuesday put up a united face ahead of the assembly polls. Nath in a message on X in Hindi on Thursday said the party has

issued the second list comprising 88 candidates and extended his best wishes to all of them. "You are not just standing in the assembly polls to become an MLA, but to change the future of the state," he added. The party has replaced Avdesh Nayak with senior Congress leader Rajendra Bharti in Datia from where BJP candidate and the state home minister Narottam Mishra is contesting for the fourth time. Mishra won from Datia in 2008, 2013 and 2018 assembly elections. The party also changed the ticket from Goteagaon (SC) seat from where it replaced Shekhar Choudhary with the sitting MLA and former Assembly Speaker Narmada Prasad Prajapati. The Congress leadership also replaced Shailendra Singh with Arvind Singh Lodhi from

Pichhore seat in Shivpuri district in view of the protest by the party workers. The party has fielded former minister and sitting MLA PC Sharma from Bhopal South West constituency. The Congress has given ticket to sitting MLA Arif Aqeel's son, Atif Aqeel from Bhopal North, despite opposition by Arif's younger brother Aamir Aqeel. The BJP has fielded former Bhopal Mayor Alok Sharma from there. Among the prominent leaders who got the ticket for contesting assembly polls include former minister Choudhary Rakesh Singh Chaturvedi from Bhopal, Subhash Sojatia from Garoth and Rajkumar Patel from Bhopal seats. The party also fielded Ravinder Singh Tomar from the Dimni assembly seat and he will con-

test against Union Agriculture Minister Narendra Singh Tomar. From the Gwalior assembly seat, considered the bastion of Union minister Jyotiraditya Scindia, the Congress has fielded Sunil Sharma, who had unsuccessfully contested in a bypoll against sitting MLA and minister Pradhman Singh Tomar, a known Scindia loyalist. Besides, the party has fielded BJP-turned-Congress leaders Deepak Joshi from Khategaon and Bhanwar Singh Shekhawat from Badnawar seats for the assembly polls. The single-phase polling for the 230-member Madhya Pradesh Assembly will be held on November 17 and counting of votes will take place on December 3, along with other poll-bound states.

Cheat who committed crime by distracting victim caught

Hanumanganj police have arrested a fraudster who committed theft by distracting victims in the name of spilling oil in the state capital Bhopal, accused has admitted to committing three crimes, stolen goods worth Rs 2 lakh have been recovered. The accused has also admitted to stealing oil worth Rs 2 lakh after spilling oil from the drug dealer's car, sprinkling chemicals in the car to create smoke. This was the biggest theft among the three incidents. In this case the police could not recover the goods from the possession of the

accused. The arrested accused are being interrogated in relation to their absconding associates. DCP Riyaz Iqbal said that on Thursday, information was received that a boy was standing near Irani Dera on the parallel road with a brown leather bag in his hand near Bhopal Railway Station. The police searched and detained the accused who was identified as Shivam Jadhav of Ratlam. During the search of the bag, a pen drive, hard disk, charger and a brown colored bag were found. The accused told that on October 13, he had stolen from a white colored car going towards the station. During

investigation, the stolen laptop, hard disk, pen drive, charger and a colored photocopy of the Aadhaar card in the name of the complainant were recovered. During further interrogation, the accused told that on October 2 and October 14, goods worth lakhs of rupees were stolen from two cars in Hanumanganj area. He had committed the crimes with his aids.

Chouhan jeers at INDIA over SP tickets

Madhya Pradesh Chief Minister Shivraj Singh Chouhan on Friday took a dig at the INDIA bloc after its constituents fielded candidates against each other in assembly polls, saying the Opposition grouping is driven by the motto of "friendship in Delhi and wrestling in states". INDIA members Congress, the Samajwadi Party (SP) and the Aam Aadmi Party (AAP) have separately announced candidates for the November 17 assembly polls in Madhya Pradesh, clearly indicating the bloc is not working at state-level. Upset with the Congress for not conceding any seat so far for the SP in Madhya Pradesh, its president chief Akhilesh Yadav on Thursday hinted the grand old party could get the same treatment from his outfit in Uttar Pradesh. In stinging remarks that exposed chinks in the opposition INDIA grouping, Yadav said the Congress leadership should not allow its "small leaders" to comment on his party. The SP and the AAP have announced candidates on multiple seats for

polls in the BJP-ruled state, which has a 230-member assembly. Latching on to apparent cracks in the recently formed bloc of more than two dozen parties, Chouhan dubbed it an incoherent coalition and called it 'ghamandia' (arrogant). "We have been saying from day one that this is a 'bemail gathbandhan (out of sync coalition). It is like friendship in Delhi (Centre), and wrestling in states. Neither their views are similar nor their hearts are at the same place. It is falling apart because of the popularity of Prime Minister Narendra Modi," the BJP leader said in a statement issued to the media. He said SP president Yadav has said the Congress kept him in the dark for a year and later "ditched" his party over allocation of seats. Chouhan remarked the Congress, the SP and the AAP are fighting against each other in Madhya Pradesh and wondered what kind of grouping is INDIA (Indian National Developmental Inclusive Alliance). "People are surprised with their behaviour. When they (INDIA constituents) are fighting against each other in states,
