## भारत की जीडीपी वृद्धि

नई दिल्ली ■ भाषा

देश की आर्थिक वृद्धि दर जून तिमाही में छह साल के निचले स्तर पर जाने के बाद अब आने वाली तिमाहियों में धीरे-धीरे सुधरेगी। हालांकि यह पहले ही अपेक्षा कमजोर रह सकती है। फिच सॉल्यूशंस ने सोमवार को अपनी एक रपट में चालू वित्त वर्ष के लिए देश की आर्थिक वृद्धि दर का अनुमान घटा दिया है। पहले यह 6.8 प्रतिशत थी जिसे अब 6.4 प्रतिशत कर दिया गया है।

देश की वास्तविक आर्थिक वृद्धि दर 2019-20 की पहली तिमाही में पांच प्रतिशत रही है। वित्त वर्ष 2018-19 की चौथी तिमाही (जनवरी-

## वाहन बिक्री में गिरावट जारी, सियाम ने सरकार से मांगी मदद

नई दिल्ली ■ भाषा

वाहन बाजार में सुस्ती का सिलसिला जारी है। अगस्त में वाहनों की बिक्री में 30 प्रतिशत की जोरदार गिरावट रही। वाहन विनिर्माताओं के संगठन सियाम ने सोमवार को कहा कि सरकार को वाहन उद्योग को रफ्तार देने के लिए तत्काल कदम उठाने चाहिए। सियाम ने सरकार से वाहनों पर माल एवं सेवा कर (जीएसटी) दरों में कटौती और पुराने वाहनों के लिये कबाड़ नीति लाने की मांग की है।

सियाम ने कहा कि वाणिज्यिक और दोपहिया वाहनों में भी गिरावट जारी है। इससे पता चलता है कि वित्त मंत्री निर्मला सीतारमण ने जिन उपायों की घोषणा की है बाजार ने अभी उन पर प्रतिक्रिया नहीं दी है। सियाम के अध्यक्ष राजन वडेरा ने बयान में कहा कि गिरावट के इस दौर के बीच उद्योगों ने अपने उपभोक्ताओं को काफी आकर्षक रियायतें दी हैं। उन्होंने कहा, "उद्योग की बड़ी छूट देने की क्षमता सीमित है। ऐसे में सरकार को वाहनों की लागत को कम करने के लिए जीएसटी दर को

28 से घटाकर 18 प्रतिशत करना चाहिए। इससे नये वाहनों के लिये मांग बढ़ेगी।"

उन्होंने कहा कि वाहन उद्योग के सभी खंडों के लिए प्रोत्साहन आधारित कबाड़ नीति भी लाने की जरूरत है। वित्त मंत्री ने इसका वादा भी किया है। वडेरा ने कहा कि त्योहारी सीजन नजदीक है। ऐसे में यह जरूरी हो जाता है कि इस पर फेसला तत्काल लिया जाए और इनकी घोषणा बिना विलंब के की जाए। इससे उद्योग के लिए त्योहारी सीजन बेहतर रहेगा। वडेरा ने कहा कि ऋण की उपलब्धता और इसकी लागत में कटौती के बारे में कई घोषणाएं की गई हैं लेकिन गैर बैंकिंग वित्तीय कंपनियों (एनबीएफसी) तक इनका फैलाव नहीं हो पाया है, जबकि यही क्षेत्र वाहनों के लिए विशेषरूप से कर्ज उपलब्ध कराता है। उन्होंने कहा कि उपभोक्ता धारणा भी कमजोर है। रविवार को कई वाहन कंपनियों मसलाने मारुति सुजुकी इंडिया, हुंदे, महिंद्रा एंड महिंद्रा, टाटा मोटर्स और होंडा के अगस्त माह की बिक्री के आंकड़े आए हैं।
