

The company has made a loss of Rs. 3,514,689/- during the financial year.

The Board of the Company has decided not to carry any amount to Reserves.

Ushadevi Shivkumar Ladha (DIN:06964508) and Shri Sadashiv Salian (DIN:05346842) are the other Directors on the board. There was no appointment or resignation of Directors during the financial year.

Shri Rupesh Anil Kadam has resigned from the post of the Chief financial officer of the Company with effect from 30.05.2019 and Shri Ankesh Deepak Ghole was appointed as the Chief financial officer of the Company with effect from 30.05.2019. Shri Rohit Bhagwat was appointed as the Company Secretary and Compliance Officer of the Company with effect from 30.05.2019.

The Board has appointed M/s Arun Dash & Associates, Company Secretaries, to conduct Secretarial Audit for the financial year ended March 31, 2020 and Secretarial Audit Report is annexed herewith marked as **Annexure III** to this Report.

The Secretarial Audit Report contains the following qualifications i) The Company has not appointed a whole time Company Secretary as provided u/s 203 of the Companies Act, 2013 and the rules framed

thereunder till May 29, 2019. ii) the Company has preference shares which are yet to be redeemed and (iii) the promoter(s) shareholding is not maintained in 100% dematerialized form.

The Company has appointed Shri Rohit Bhagwat w.e.f 30.05.2019 as its whole time Company secretary, the company is taking utmost efforts in redemption of preference shares and the company is taking adequate steps to de-materialize hundred percent of shares of the promoters.

On transition to Ind AS, the company has adopted optional exception under Ind AS 101 to measure Property, Plant and Equipment at fair value.
