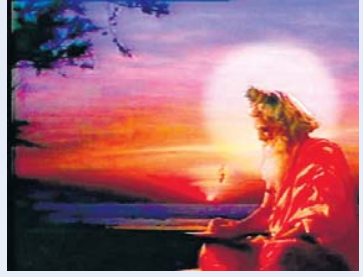

आत्मबोध संपन्न वसिष्ठ गीता

अध्यात्मविद्येतो हे एक आत्मबोध संपन्न असं प्रकरण आहे. योगवासिष्ठ सर्गां ३९ आणि ४० या सर्गामध्ये मर्यादा पुरुषोत्तम श्रीरामचंद्र प्रभूंनी शरणगात होऊन आपले आध्यात्मिक सदगुरु असलेल्या वसिष्ठ ऋषींना जीवनाच्या मूळ उगमाचा, अधिष्ठानाचा आणि आत्मज्ञानाचा परिप्रश्न केल्यावरच अत्यंत परमगुह्य दिव्यज्ञान त्यांनी प्रभू रामचंद्रास वसिष्ठ गीतेच्या रूपात कथन केलं असून या गीतेतील दोन्ही सर्गांतील एकोणपन्नास संस्कृत श्लोकांतून आत्मबोध सांगितलेला आहे.



वसिष्ठ गीता आत्मबोधाने अतिशय समृद्ध आहे. सच्चिदानंद स्वस्वरूपाकार झालेला गुरुपुत्र आत्मतत्त्वामध्ये विश्रंती घेत असताना कोणत्या रूपाने अवशिष्ट राहतो व समग्र जगत त्याला कसं दिसतं. संसारात ब्रह्म म्हणजे आत्मतत्त्व भासत नाही व आत्मतत्त्वामध्ये संसार भासत नाही. परंतु जीवनमुक्त पुरुष जीवनात प्राप्त आयुष्यात विहरत आणि विचरत असता पर्यायाने दोन्ही त्यास भासतात, याचं समग्र पण संक्षिप्त वर्णन या वसिष्ठ गीतेंत आलेलं आहे. या गीतेत श्रीवसिष्ठमुनी प्रभू रामचंद्रास म्हणतात, 'परमार्थ अभ्यासताना आत्मतत्त्वाला साक्षात्कार झाल्यामुळे ज्याला संसारच ब्रह्मरूप झालेला आहे, असा साधक शिष्योत्तम नियमानुसारच लोकभय आणि निसर्गनियम व आध्यात्मिक आचारसंहितेचं अवलंबन करून समाजास आदर्शवत जीवन जगत असतो. तो संकल्प वा विकल्पातील संकल्प अलिप्तपणे त्याच्याकडून मानवाच्या

व्यवहारप्रमाणे होतो. त्याचा तो संकल्पच स्वात्मच आहे, असं तो अनुभवतो. तो समग्रपणाने सर्वांनाच आत्मवत पाहतो. त्याला फक्त संकल्पाभास जाणवतो. आश्रवार जशी तोंडातील वाफ सोडली असता तो मलीन दिसतो, त्याप्रमाणे चैतन्यशुद्ध होण्यापूर्वी, आत्मज्ञान व आत्मसाक्षात्कार होण्यापूर्वी काही
