Subject: Response with respect to in-correct data submitted by Company for outstanding borrowings in "Annexure A" - Format of the Initial Disclosure to be made by an entity identified as a Large Corporate.

This is reference to your letter dated 04 March 2023 read with SEBI Circular SEBI/HO/DDHS/CIR/P/2018/144 dated November 26,2018 with respect to "Fund Raising by issuance of Debt Securities by Large Entities" and disclosures stipulated thereunderwherein you have raised a query that the outstanding borrowing data submitted by the Company in "Annexure A" on May 13, 2022 is not correct.

We would like to inform you that that the total outstanding long-term borrowing of the Company as on 31 March 2022 is INR 8.17 Crores instead of INR 58425570/-(wrongly mentioned in the Annexure A dated May 13, 2022) which is less than INR 100 Crores. The same can also be verified from the annual report for the FY 2021-22 filed by the Company with your good offices.

Hence, in terms of the above explanation, Precision Electronics Limited (the 'Company'), does notfall underthe purviewofa"Large CorporateEntity" envisaged underthe SEBI Circular SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018, accordingly the Company is not required to make any disclosure/announcement to the stock exchange.
