Matter pending with Additional Director General of Foreign Trade, Ahmedabad, for recovery of Terminal Excise Duty (TED) refund pertaining to supply made against Advance Release Order (ARO) under Foreign Trade Policy 2009-2014.

The brief of the matter is as under:

- The Company received a Show Cause Notice dated November 28, 2019 bearing number F.No./TED/ARO/Recovery/AM20.8818 from the Additional Director General of Foreign Trade, Ahmedabad, stating that the Company is not entitled for TED refund which was erroneously paid and, that, therefore the Company payback the amount of Rs. 49.99 Crores.
- In response the Company has filed a Writ Petition in the High Court of Gujarat at Ahmedabad stating that the said action is bad in law on various grounds and time barred as it has been initiated after expiry of limitation period as provided under Section 16 of the Foreign Trade (Development and Regulation) Act, 1992.
- The Hon'ble Court heard the matter and granted interim stay vide order dated December 17, 2019.

The brief of the matter is as under:

- A fire broke out in the Company's Unit situated at Udhampur, Jammu & Kashmir late night on May 27, 2021. This has been intimated to the Stock Exchanges on May 28, 2021.
- Company has filed the request with the Insurance Company for the claim just after the incident took place.
- The Insurance Company has recently appointed Forensic Investigator to investigate the said matter.
- As of now no claim is received by the Company from the Insurance Company. The Company is expecting to receive the full claim within this financial year.
