In the light of the COVID-19 epidemic which has been declared a pandemic, the Company has been taking precautionary measures to protect the business and employees. Critical response teams have been setup across the organization to plan scenarios and respond in an agile manner to rapidly changing situation.

To ensure the safety and well-being of the employees, all recommended precautions against COVID-19 have been taken, which includes work from home policy for eligible employees, restrictions on travel, minimizing contacts in public, health advisory to employees following State and Central government directives issued in this regard from time to time.

All the facilities at plants/plantations have been sanitized so that our people are safe and secure. All safety protocols of temperature sensing, wearing of safety gears (masks), social distancing, sanitizing and washing hands are being adhered to strictly.

#### Tea Plantations:

The operations were shut down in the last week of March, 2020 and field/ factory work commenced in phases from April,2020 with normal operations from May,2020 onwards. Overall impact has been low.

### **Coffee Plantations:**

Cultivation activities were not affected. However, there was delay in shipments due to restriction on movement of goods.

# **Electromags Division:**

The Manufacturing plant was shut down from last week of March, 2020 and it resumed its operations partially from the first week of May, 2020.

#### **Healthcare Business:**

The Dental industry has been impacted due to covid-19 as the dental colleges and clinics have remained closed. However, manufacturing operations started in phases from mid -April, 2020.

The Corporation has managed the immediate challenges of re-establishing normalcy in some of its business operations. However, considering the fact that the situation is exceptional and is changing constantly, the Corporation is not in a position to gauge with certainty, the implications on its operations. The Company will continue to monitor all changes as the situation evolves.
