The scrubber is designed to bring down the sulphur dioxide in flue gas by 25%, going a long way in checking emissions and helping the environment.

India likely to see first woman chief of financial regulator

New Delhi, India may well get the first female chief of a financial regulator as two women feature among the top candidates for the post of IRDAI Chairperson. Former Telecom Secretary Aruna Sundararajan and the Securities and Exchange Board of India's (SEBI) Whole Time Member, Madhabi Puri Buch, are in the race for the next Chairperson of the Insurance Regulatory and Development Authority of India, highly-placed sources told IANS.

According to Keerthi, some long serving women pilots had availed duly approved and sanctioned maternity leave. The said pilots were eligible to be given service benefits. "However, to their utter shock and complete dismay, the said pilots are appalled to find out that their names

either do not find a place at all or have been incorrectly mentioned in the Upgradation List, thereby amounting to a denial of due service benefits to them and adversely affecting their seniority," the letter notes. "While no explanation, written or otherwise, has been shared officially by the AI management in this regard, it appears that there is no other reason, apart from the fact that each said pilot was on a duly sanctioned and approved leave, and it is on that account that they have been denied their rightful place in the Upgradation List," Keerthi said.

Sensex tad down amid choppy trade; telecom stocks rise

Mumbai, The key Indian equity indices traded on a subdued note on Wednesday morning. The indices were pulled lower by the fall in shares of index-heavyweights Infosys and Tata Consultancy Services. Around 10.20 a.m., Sensex was trading at 58,230.99, lower by 48.49 points or 0.08 per cent from its previous close of 58,279.48. It opened at 58,350.56 and has so far touched an intraday high 58,372.94 and a low of 58,169.36 points. The Nifty50 on the National Stock Exchange was trading at 17,345.45, higher by 16.65 points or 0.1 per cent from its previous close. However, bucking the subdued telecom stocks rose amid hopes of a relief package. The Union Cabinet is expected to discuss relief measures for the stressed sector on Wednesday. Shares of Bharti Airtel on the BSE have touched a 52-week high of Rs 684 per share. Vodafone Idea shares surged 4.7 per cent to Rs 8.67 per share.
