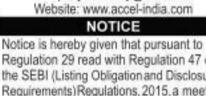

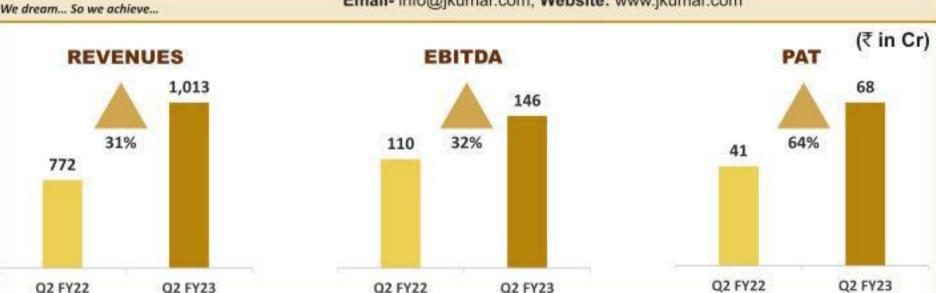

# अभियोजन पक्ष नहीं पेश कर सका स्पष्ट साक्ष्य

पीठ ने इस निष्कर्ष के आधार पर तीनों दोषियों को बरी कर दिया कि अभियोजन उनके खिलाफ लगाए आरोपों को कानूनी कसौटी पर

संदेह से परे साबित करने में नाकाम रहा। इन दोषियों को सेशन अदालत ने फांसी की सजा सुनाई थी। जिसे बाद में दिल्ली हाईकोर्ट ने भी हरी झंडी दिखाई थी।

सुप्रीम कोर्ट ने इस मामले में निचली अदालत की कार्य प्रणाली की भी तीखी आलोचना की है। पीठ ने कहा है कि अदालतों को अपने फैसले विधि सम्मत गुणदोष के आधार पर करने चाहिए। किसी भी तरह के बाहरी नैतिक दबाव से प्रभावित नहीं होना चाहिए। लेकिन इस मामले में निचली

## यूएपीए के 40 मामलों में 90 दिन के अंदर आरोपपत्र दाखिल किए : पुलिस

दिल्ली पुलिस ने उच्च न्यायालय को सूचित किया है कि उसने गैरकानूनी गतिविधियां (रोकथाम) कानून (यूएपीए) के तहत 2005 से अब तक 83 मामले दर्ज किए और उनमें से 40 मामलों में 90 दिनों के अंदर आरोपपत्र दाखिल किए गए जबकि 20 मामलों में समयसीमा बढाने निर्देश पर ये आंकड़े पेश किए गए।

अदालत यूएपीए के एक आरोपी की याचिका पर सुनवाई कर रहा थी जिसमें उसके खिलाफ मामले में दिल्ली पुलिस को दी गई 90 दिनों की समय सीमा बढ़ाने की सुनवाई के फैसले को चुनौती दी गई है। पुलिस ने बताया कि आतंकवाद विरोधी कानून के तहत कुल 98 मामले दर्ज किए गए थे लेकिन उनमें से 15 मामले राष्ट्रीय जांच

का अनुरोध किया गया। दिल्ली उच्च न्यायालय के अभिकरण (एनआइए) को स्थानांतरित कर दिए गए। न्यायमूर्ति मुक्ता गृप्ता और न्यायमूर्ति अनीश दयाल ने अंक्तूबर में पुलिस को यूएपीए के तहत उन मामलों की संख्या बताने को कहा था, जिनमें उसने निर्धारित 90 दिनों की समयसीमा के भीतर आरोपपत्र दाखिल किए थे। उच्च न्यायालय ने पुलिस से उन मामलों का भी खुलासा करने को कहा था जहां 90 दिन की समय सीमा बढाने के अनुरोध के बाद आरोपपत्र दायर किया गया था।

## केजरीवाल, जैन और सुकेश का 'पालीग्राफ' परीक्षण होना चाहिए: मनोज तिवारी

सुप्रीम कोर्ट ने नोएडा और ग्रेटर नोएडा की रियल एस्टेट कंपनियों को एक बडा झटका दिया है। सर्वोच्च अदालत ने अपने जून 2020 के आदेश को वापस ले लिया है। जिसमें बिल्डरों को पट्टे पर दी गई जमीन के लिए बकाया राशि पर ब्याज की दर आठ फीसद सालाना थी। प्रधान न्यायाधीश उदय उमेश ललित और न्यायमर्ति अजय रस्तोगी की पीठ ने सोमवार को इस आदेश को वापस ले लिया।

दरअसल, सुप्रीम कोर्ट ने 2020 में नोएडा और ग्रेटर नोएडा में बिल्डरों द्वारा भूमि की कीमत के भुगतान में देरी होने पर लगने वाले 15-23 फीसद ब्याज दर को आठ फीसद तक सीमित कर दिया था।

इस मामले की सुनवाई में नोएडा और ग्रेटर नोएडा प्राधिकरण की तरफ से वरिष्ठ वकील रवींद्र कुमार ने अदालत को बताया कि बिल्डरों की ओर से भुगतान में देरी होने पर ब्याज दर की सीमा को आठ फीसद तक करने के आदेश के चलते प्राधिकरणों को 7500 करोड़ रुपए से ज्यादा का

नुकसान उठाना पड़ेगा। जिससे काम-काज लगभग ठप हो गया है। अदालत को सरकारी वकील ने यह भी बताया कि अदालत का आदेश तथ्यों के आधार पर नहीं दिया गया है। इससे प्राधिकरण वित्तीय तौर पर संकट में आ जाएंगे। वहीं बिल्डरों के लिए ब्याज दरों में कमी का फायदा होम बायर्स को भी नहीं मिलने वाला है।

जून 2020 में आम्रपाली मामले की सुनवाई करते हुए अदालत ने कहा था कि रियल एस्टेट क्षेत्र को प्रोत्साहन देने और बिल्डरों को राहत देने की आवश्यकता है। उनमें से कई महामारी के कारण आर्थिक मंदी के कारण संघर्ष कर रहे हैं।
