राज्याच्या दुर्गम आदिवासी तसेच नक्षलग्रस्त भागात काम करणाऱ्या भरारी पथकाच्या डॉक्टरांना टप्प्याटप्प्याने सेवेत कायम करण्याबरोबर त्यांच्या मानघनात वाढ करण्यासाठी लवकरात लवकर निर्णय घेतला जाईल, असे आरवासन आरोग्यमंत्री एकनाथ शिंदे यांनी बुधवारी पथकाच्या डॉक्टरांना दिले. आरोग्य विभागात ११९५ पासून नवसंजीवन योजनेअंतर्गत २८२ डॉक्टर भरारी पथकात काम करीत आहेत. अतिदुर्गम आदिवासी भागात काम करणाऱ्या या डॉक्टरांना पुरेशा सुविधा मिळाल्या नाहीत तसेच केवळ २४ हजार रुपये मानघनापोटी मिळतात. त्यातही आरोग्य विभागाकडून १८ हजार रुपये तर आदिवासी विभागाकडून सहा हजार रुपये देण्यात येतात.

'आशा कार्यकर्त्यांच्या मानधनात वाढ करणार'
