'जी -२०'च्या शिखर परिषदेला चीनचे अध्यक्ष क्षी जिनपिंग व रशियाचे अध्यक्ष व्लादिमीर पुतिन हे दोन्ही राष्ट्रप्रमुख उपस्थित राहणार नाहीत. युक्रेन युद्धामुळे पुतिन यांनी सहभागी होण्याचे टाळले असून जिनपिंग यांनी भारताशी बिघडलेल्या संबंधांपेक्षा चीनमधील राजकीय आव्हानांमुळे शिखर परिषदेपासून दुर राहण्याचा निर्णय घेतल्याचे मानले जात आहे. दोन्ही गैरहजेरीशी राष्ट्रप्रमुखांच्या
