# CAMS Q1 PAT up 2.4% to R5 65 crore

New Delhi: Registrar and transfer agent for mutual funds Computer Age Management Services on Saturday reported a 2.4 per cent growth in profit after tax to Rs 64.78 crore for the April-June quarter of this fiscal. The company had posted a PAT of Rs 63.24 crore in the same quarter of the last fiscal, Computer Age Management Services Ltd. (CAMS) said. Its revenue rose 17.6 per cent to Rs 236.65 crore in the quarter under review from Rs 201.18 crore in the three months to June 2021. Anuj Kumar, Managing Director CAMS Ltd., said that despite the volatile market situation, individual investor confidence remained high with buoyant equity net inflows supported by predictable, strong SIP (Systematic Investment Plan) collections of nearly Rs 7,000 crore every month. New SIPs clocking 10 lakh plus monthly registrations is another key trend pointing to mutual fund as the preferred route for long-term investors, he said. Our share in assets under management (AUM) is at a robust 69 per cent serving 10 of the top 15 mutual funds. Our equity AUM expanded by 2.6 per cent quarter on quarter while our overall AUM saw a marginal decline of 1.6 per cent.

### Cabinet clears proposal to enhance ECLCS corpus to Rs 5 lakh cr

New Delhi, (IANS) The Union Cabinet on Wednesday approved a proposal to enhance the outlay of Emergency Credit Line Guarantee Scheme (ECLGS) by Rs 50,000 crore from 4.5 lakh crore to Rs 5 lakh crore for the tourism and hospitality sector, which had faced disruptions due to the Covid-19 pandemic. Information and Broadcasting Minister Anurag Thakur told mediapersons after the Cabinet meeting that the additional amount of Rs 50,000 crore would be given to the hospitality sector till the validity of ECLGS, i.e., till March 31, 2023. ECLGS is an ongoing scheme. According to an official statement, the enhancement would provide relief to the tourism and hospitality sector by incentivising banks to provide additional credit of up to Rs 50,000 crore at low cost, which would help enterprises under the sector meet their operational liabilities.

# Bharti Airtel pays Rs 8,312 cr for spectrum upfront

Chennai, Aug 17 (IANS) Telecom major Bharti Airtel on Wednesday said it has paid Rs 8,312.4 crore to the Centre towards dues for spectrum acquired in the recently concluded 5G auctions. The company has paid four years of 2022 spectrum dues upfront. According to the company, the upfront payment coupled with the moratorium on spectrum dues and adjusted gross revenue (AGR) related payments for four years, will free up future cash flows and allow it to dedicate resources to singlemindedly concentrate on the 5G roll out. Over the last one year, Bharti Airtel has also cleared Rs 24,333.7 crore of its deferred spectrum liabilities much ahead of scheduled maturities.
