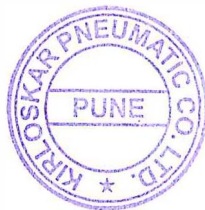

Note: "In the matter of Order No. WTM/MPB/IVD/ID1/139/2020 dated October 20, 2020 passed by SEBI ("SEBI Order") against certain promoters and directors of the Company in relation to the investigation in respect of dealings in the scrip of Kirloskar Brothers Limited in 2010, the Hon'ble Securities Appellate Tribunal (SAT) vide its order dated October 12, 2022, has set aside the SEBI Order, thereby exonerating the said promoters and directors of the Company from the charges of insider trading and fraudulent trade practices levied by SEBI against them. No appeal against the SAT Order has been filed by SEBI. Therefore, the matter has been disposed off."

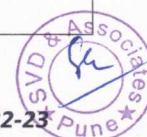

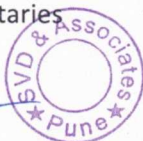
