
Dear Sir/Madam,

Sub: Rejection letter for Reclassification of Shareholders under Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir/Madam,

We refer to your application dated October 22, 2021 seeking Reclassification of Promoter Shareholders under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In this regard, your attention is drawn towards the Regulation 31A(3)(b)(i) of SEBI (LODR) Regulations, 2015 which inter-alia states,

(b)the promoter(s) seeking re-classification and persons related to the promoter(s) seeking re-classification shall not:

(i) together, hold more than ten percent of the total voting rights in the listed entity.

It is observed from the Company application, shareholding pattern submitted by the company and other submissions made in this regard that the outgoing promoters and continuing promoters together, hold more than ten percent of the total voting rights in the listed entity.

Hence, the application of the Company is not meeting the requirement as mandated provisions of Regulation 31A(3)(b)(i) of SEBI (LODR) Regulations, 2015.

In view of the above circumstances, since the Company fails to meet the criteria specified under the Regulation 31A(3)(b)(i) of SEBI (LODR) Regulations, 2015, the Company's application for Reclassification of promoters is rejected.
