**Summary of the proceedings of the 14<sup>th</sup> Annual General Meeting of Shemaroo Entertainment Limited held on September 24, 2019**

The 14<sup>th</sup> Annual General Meeting of the Members of the Company was held on September 24, 2019 at 04:00 P.M., at M. C. Ghia Hall (Royal Banquet), 4th Floor, Bhogilal Hargovindas Building, 18/20 K Dubash Marg, Kala Ghoda, Mumbai – 400001.

Mr. Buddhichand Maroo, Non- Executive Chairman of the Company, chaired the Meeting. In aggregate, 54 Members were present at the AGM. The requisite quorum being present, the Chairman called the meeting to order.

Mr. Raman Maroo, Managing Director, welcomed the members to the 14<sup>th</sup> Annual General Meeting of the Company and introduced the Directors present on the dais and also informed that Mr. Kirit Gala, Mr. VasANJI Mamania and Mr. Shashidhar Sinha could not attend the meeting due to their pre-occupations.

Mr. Raman Maroo addressed the members by giving brief note on the Company's brand identity; launch of ShemarooMe, a video streaming platform; invest in professional talent etc. Further, Mr. Hiren U. Gada, CEO & CFO also addressed the Members and presented an overview of the financial performance of the Company for the financial year ended March 31, 2019 and its future outlook.

The Members were informed that the following registers and documents were available for inspection during the meeting:

The e-voting period commenced on September 21, 2019 at 09:00 AM and end on September 23, 2019 at 05:00 PM.

The Members were informed that the facility for voting through Ballot paper is made available at the Meeting for members, who have not cast their vote using the remote e-voting and Mr. Manish Ghia of M/s. Manish Ghia & Associates, Practicing Company Secretary have been appointed as the Scrutinizer for the purpose of scrutinizing the entire voting process in a fair and transparent manner.

The Company Secretary then invited the members to ask questions, make comments and give their views / suggestions, if any. The members were given opportunity to speak in the order in which they had given their names and all the questions raised were answered satisfactorily by Mr. Hiren Gada, CEO & CFO of the Company.

The Chairman then authorised Company Secretary to carry out the poll process. He announced that combined results of the remote e-voting and voting through ballot at the AGM shall be placed on the website of the Company and also on website of the Stock Exchanges within 48 hours of the conclusion of the meeting.

The meeting was ended with vote of thanks to the Chair at 05:10 PM.
