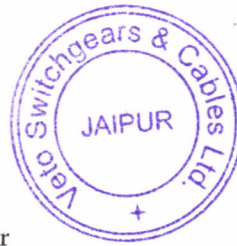

- These financial results have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" (Ind AS 34), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles.
- The above results have been reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on August 14, 2023. The Statutory Auditor, have expressed an unmodified report on the results.
- During the current quarter, the Company has acquired 100% equity interest of Inella Gabriel Sunworld Systems Private Limited (IGSSPL) and entered into a technical collaboration agreement with Inella Global Systems Group P. V. of the Netherlands (Inella) to undertake the activities of manufacturing and development of solar components through IGSSPL. The Board of Directors of the Company has also accorded its approval to execute the joint venture agreement between Inella and the Company, subject to receipt of requisite approvals, pursuant to which the establishment of Inella and the Company in IGSSPL will be in the ratio of 80:20 in accordance with the terms contained therein. The financial results for the quarter ended June 30, 2023 is the first consolidated financial result of the Company, hence there are no corresponding figures for prior periods.
- On July 14, 2023, the Company has incorporated a wholly owned subsidiary Global Europe Engineering Centre (GEEC) in Belgium to undertake research and development of solar components.
- As the Company's business activity falls within a single operating segment viz. "solar components and parts", no segment information is required to be disclosed.
- The figures for the quarter ended March 31, 2023 are the revised figures between the audited figures for the year ended March 31, 2023 and published figures of same month ended December 31, 2022, which were subjected to limited review.

- The above Unaudited Financial Results for the Quarter ended 30th June 2023 were reviewed by the Audit Committee and thereafter, approved by the Board of Directors and was held on record at the meeting held on 14th August 2023. The Statutory Auditor have carried out a limited review on the above financial results for the Quarter ended 30th June 2023.
- As per the Joint Sector Agreement (JSA) dated 23.02.1990 executed between The National Insulated Cable Company of India Limited (now known as NICO Corporation Limited) (NCL under liquidation), West Bengal Tourism Development Corporation Limited (WBTDCL) and West Bengal Industrial Development Corporation Limited (WBIDCL), the Company's land on which Amusement Park and F&B and other recreational operations are being carried out was made available to the Company for a period of 30 years with renewal clause for two more terms. Pursuant to liquidation proceedings against NCL, shares of the Company held by them has been transferred and thereby, the JSA as specified therein has become infructuous and inoperative. Moreover, the first tenure of the lease of 30 years vide agreement dated 05.07.1991 between Governor of the State of West Bengal and the Company entered on 23.02.2023. Necessary application for the renewal of lease agreement has been made with Department of Tourism, Government of West Bengal vide letter dated 14.10.2022, which is pending to be executed as on this date. As stated by the management, the application for renewal is under active consideration and tenure of lease is expected to be extended. Pending this, operations and related arrangements have been considered as ongoing as per the terms and conditions provided in the above agreement and unaudited financial results has been continued to be compiled as done before on Going Concern Basis.
- An Interim Dividend @ 50% for the financial year 2023-2024 has been approved by the Board of Directors at its 47th Meeting.
- (i) The Park operation, F & B and others recreational facilities are subject to seasonal variation.
(ii) Consultancy, contracts and sale of components for rides is also subject to variation depending upon the number of contracts.
- Previous Periods figures have been re-arranged / re-grouped wherever necessary.
