This is to inform you that on March 04, 2022 erstwhile promoters of the Company, namely Mr. Sajid Siraj Malik and Mrs. Saroja Siraj Malik entered into a Share Purchase Agreement to sell their entire stake in Teamo Productions HQ Limited (formerly known as GI Engineering Solutions Limited) ["the Company"] and cede control with Mr. Vishesh Gupta and M/s. Vrindaa Advanced Materials Limited.
