Russia's civil aviation agency said that Prigozhin and six top lieutenants were on a business jet that crashed on Wednesday, soon after taking off from Moscow, with a crew of three.

Rescuers quickly found all 10 bodies, and Russian media cited sources in Prigozhin's Wagner private military company who con-firmed his death. US and other Western officials long expected Putin to go after Prigozhin, despite promis-
