इंदौर। इंदौर की द्वारकापुरी पुलिस का एक वीडियो वायरल हुआ है। इसमें सिविल डेस में तीन पुलिसकर्मी दो यवकों और एक महिला के साथ मारपीट कर उन्हें जबरदस्ती गाडी में बैठाते नजर रहे हैं। बताया जाता है कि इलाके के हिस्टीशीटर बदमाश यहां युवकों का घर खाली कराने पहुंचे थे। परिवार ने विरोध किया तो पुलिसकर्मियों ने उनकी ही पिटाई कर दी और गाडी में बैठाकर थाने ले गई।

घटना द्वारकापरी थाने के ऋषि पैलेस कॉलोनी में बुधवार की बताई जा रही है। यहां मीराबाई और उनके बेटे सुनील और अनिल से मकान खाली करवाने कैलाश यादव और कमल मौर्य व मुनीम सुनील पहुंचे थे। मीराबाई ने बताया कि उक्त जगह पर वह करीब 15 सालों से रह रहे है।

अचानक तोडफोड कर दी। जब मामले में उन्होंने डायल 100 को सचना दी तो वहां एफआरवी गाडी में एक पुलिसकर्मी के साथ थाने के तीन जवान सिविल डेस में पहुंचे और मीरा बाइ और उनके बेटों को सडक पर बुरी तरह से पीटा। पुलिसकर्मियों ने तीनों को थाने की गाड़ी में बैठा लिया और मकान का कब्जा खाली नहीं होने तक वहीं रखा। इधर वीडियो वायरल होने के बाद वरिष्ठ अधिकारी मामले में संज्ञान लेने की बात कह रहे है।

बरामद किया है।टीआइ अभय नेमा ने बताया कि इस मामले मे आरोपित पुराने नकबजन हैं। इसके पूर्व भी चोरी और लूट के मामले में गिरफ्तार हो चुके हैं।
