Notice is hereby given that the resolutions set out below are proposed to be passed by the members of SM AUTO STAMPING LIMITED ('Company') by means of Postal Ballot, only by way of remote e-voting process ('e-voting'), pursuant to Sections 108 and 110 of the Companies Act, 2013 ('the Act'), Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ('Rules') and other applicable provisions of the Act and the Rules, Secretarial Standard on General Meetings ('SS-2') issued by the Institute of Company Secretaries of India, General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020 read with other relevant circulars, including General Circular No. 10/2021 dated June 23, 2021, General Circular No. 20/2021 dated December 08, 2021, General Circular No. 11/2022 dated December 28, 2022, and the latest one being General Circular no. 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs ('MCA Circulars') and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations'), and other applicable laws, rules and regulations (including any statutory modification or re-enactment thereof for the time being in force and as amended from time to time), that the approval of Members of SMAUTO STAMPING LIMITED ('the Company') is being sought for the following special resolution by way of Postal Ballot remote e-voting process only:

Item No.	Description of Special Resolution
1	Buyback of up to 600,000 fully paid-up equity shares of face value of Rs. 10/- each, representing 4.20% of the total issued and paid-up equity share capital, at a price of Rs. 60/- (Rupees Sixty only) per Equity Share, subject to any increase to the buyback offer price as may be approved by the board/buy back committee, payable in cash for and aggregate consideration not exceeding Rs.3,60,00,000/- (Rupees Three Crore Sixty Lakh Only) excluding all transaction costs, applicable taxes and other incidental and related expenses, on proportionate basis through tender offer route through stock exchange mechanism.
